Bird Droppings are much more than a nuisance. They are a health hazard.

Avoid health risks resulting in sickness, infection, and disease.

Bird droppings contaminate food, water, and anything they touch. They release airborne spores that can be inhaled by customers and workers. They also carry disease causing parasites, fleas, ticks, mites, lice and other biting insects. Bird droppings attract other pests, including rats and mice. Droppings can also pose a potential slip and fall hazard leading to injuries, insurance claims, and law suits.

If left to accumulate, droppings and nesting can be a costly and potentially dangerous problem.

Nests block drainage systems and obstruct ventilation ducts. Bird

droppings are highly caustic and eat away roofing, support beams, and other structural materials. Electrical cables corroded with bird feces can create an electrical short causing a fire hazard. This can put you, your employees, your guests, and your facility at risk.



Did you Know?

Inhaling bird feces can cause an incurable disease called histoplasmosis, characterized by constant flu-like symptoms.

Nests in chimneys and vents can block the proper exhausting of carbon monoxide. This can lead to a hazardous build up of carbon monoxide and mold within a property.

Bird Control Methods


The traditional methods for dealing with these bird issues has been to use toxic pesticides and often messy repellants. The pesticides have drawn the criticism of both the public, and groups like PETA. Secondary poisoning to non-target species (including birds of prey, coyotes and others) is also a factor that will dissuade us from selecting these approaches.




Exclusion Services:




Our bird exclusion service is designed to permanently exclude birds from potential nesting and perching areas on or inside structures. These areas include roof intersections, eaves, ledges, beams, gutter down spouts, chimneys, attics, etc. We focus on these specific areas, because birds require nesting sites year-round and habitually perch on the buildings that they nest on.











These products are removable and very low-visibility.

Bird "Birth Control":

Pigeons breed rapidly – just five mating pairs can produce up to 400 pigeons in only two years. Fortunately, the life-span of urban pigeons is short, limited to just 2-3 years. Ovo Control method will essentially become a "birth control" program for pigeons, and will interfere with their normal reproductive cycles.



The consumption of the bait will sterilize the populations and within one year, we expect a 50% reduction in resident pigeon populations. Expect another 25% in year 2, and by the 3rd year, the birds should be limited to a hand full of birds which may migrate onto the facility.

The program is a strategy to control bird populations, long term.





Success through Combined Strategies

While there are many different pigeon control products, there are just a few basic strategies to manage a flock of pest birds. The tool(s) selected is most often a function of site characteristics and management objectives.

In most cases, the strategies can be combined for the best possible outcome and solution for a given site. For example, exclusion can be combined with abatement when both strategies are required to resolve the pigeon infestation.

Since they breed so rapidly, increasing mortality alone does not have a lasting effect or provide a long-term solution for the site.

OvoControl fits in the abatement category by reducing reproduction. This strategy prevents birds from simply refilling the vacuum created from increasing mortality. The population declines naturally, though attrition, with a small remaining flock to keep others from moving in.
