## **PESTMASTER SERVICES CAPABILITIES**

Pestmaster Services, Pestmaster Franchise Network, Inc., and the Kaigan Corporation are all corporations that operate under the "Pestmaster<sup>®</sup>" trademark.

We are a dedicated group of professional industry leaders in the fields of pest and vegetation management. Founded over 40 years ago, in Bishop, California, Pestmaster Services has become a nationwide provider to both private and governmental clients and has become a top provider to the DoD, either by prime or subcontracts, in the nation.

Pestmaster Services holds a GSA Federal Supply Schedule, a California Multiple Award Schedule (CMAS) as well as a Texas Multiple Award Schedule (TxMAS).

**Pest Management** – Integrated Pest Management (IPM) is a mainstay of our business model. Be it ants, roaches, spiders, bees, Africanized Honey Bees (killer bees), flies, bed bugs, flying insects, or rodents, we get to the root of the problem with doctor-like inspection and interview of our clients, so we understand their needs.

Using common sense approaches first, we employ exclusion methods, improved sanitation, monitoring, and prevention as first steps to addressing pest problems. We are not a "spray" company, so should actual treatments be needed to control pests, non-toxic methods are always a first choice.

Since we believe the key to controlling pest problems is technical knowledge and skills, our staff is mandated to become state licensed or certified. Beyond that, Pestmaster insists that competencies are tested and skills refined as our employees grow with us.

"Green" Pest Management is the *only* pest management services we offer. If you're a client who mandates this, you could not find a better service partner than Pestmaster Services!

**Structural Pest Control** – termite inspections, control services for subterranean, drywood, and Formosan termites, as well as wood destroying beetles, are tasks we take on and accomplish routinely. We also provide services for other wood destroying organisms such as powder post beetles and fungus. Structural repairs for damages caused by these pests also offered at select Branch Offices and franchise locations.

**Landscape Pests** – below ground varmints including gophers, pocket gophers, ground squirrels, moles, voles and similar species can be effectively eliminated with minimal or no use of pesticides.

**Mosquito Control** – surveillance and control measures for both larvae and adult mosquitoes are essential to the quality of life and health of our clients. Vector control in aquatic environments, ULV fogging operations, documentation of services and counts, and interface with public programs are offered. As with other services, non-pesticide approaches are always considered first.

**Bird Control** – inspection, decontamination, and exclusion services for pigeons, sparrows, and other nuisance birds in, on, or around facilities. We can install exclusion material such as spikes or can install full netting systems on buildings or hangars. We also provide services for bat exclusion.

Hantavirus – specialized decontamination services for areas with rodent activity suspected of being contaminated with Hantavirus are offered as part of our menu of life protecting menu of "Health Related" services.

**Rodent / Insect Monitoring –** Pestmaster offers unique reporting tools as part of its commercial services package. These include inspection techniques that include bar coding of rodent stations, and insect monitors. These are downloaded from scanning equipment and the reports are provided to the customer to ensure that services are performed, and that there is no question that services are completed according to our mutual agreements.

Need documentable quality control? Besides bar coding, GPS tracking of service vehicles verifies treatment times and locations serviced 24/7.

**Pre-Emergent Vegetation Management** – application of specific herbicides to prevent or control weed growth. Especially well suited for road shoulders, railroad ROW's, utility sites, munitions areas, etc.

**Selective Vegetation Management** – application of herbicides to control weed species while allowing non target species to grow (such as grass species in a landscape area).

**Non-Selective Vegetation Management** – application of herbicides to achieve a total bare ground effect (such as along flight lines, road shoulders, or railroads)

**Aquatic Vegetation Management** – application of selected materials to control both weed and algae species in aquatic environments. We employ 2 airboats to accomplish this, as well as smaller boats and amphibious equipment, and metering equipment for sites like irrigation channels and canals.

**Noxious and Exotic Weed Management** – many species have been introduced to the U.S.A. and now threaten our native plant communities and endangered plants and animals. Some of them include arundo donax, tamarisk, various thistle species, kudzu, and pepperweed. We are industry leaders in the removal of these species and have specialized equipment available for large scale removal projects.

**Heavy Equipment Weed Control Operations-** cutting and mulching of the largest weed problems, including arundo, salt cedar, Chinese tree of heaven, etc. Equipment includes Hydro Axe 721e with ROWMEC cutter, Mustang rubber track with FECON head, and Excavator with long reach cutter head.

**Tree Trimming, Mastication, Fire Breaks, Chipping and Removal-** Do you need fire breaks? Road shoulder brushing? Hazard tree removal? Site clean up? All these services are offered and professionally handled.

**Entomologist-** Pestmaster Services has access to a registered professional entomologist who can be called upon for advice, consultation, or recommendation.
