Effective Testimony Tips:

The most effective testimonies from advocates like you are personal stories of your experiences and how they relate to the bill at hand. Organizations will focus on sharing facts with legislators and answering technical questions. Advocates have the advantage of connecting with legislators on a more personal level, sharing heartfelt, relatable stories that are effective and impactful.



Testifying Before a Committee:

- 1. Bring 20 copies of your testimony*
- 2. Wait until the bill sponsors and legislators have spoken, then take your turn at the podium.
- 3. Sign in, name and town
- 4. Address the entire committee.
- 5. Return to audience seating when there are no further questions.

Writing to Legislators/Submitting Online Testimony:

- 1. Introduce yourself.
- 2. Mention where you live or visit.
- 3. Ask them to support/oppose a specific bill.
- 4. Share a short personal story.
- 5. Be concise and rational.
- 6. Include your contact information and say thank you!



Calling Legislators:

- 1. Introduce yourself.
- 2. Explain the reason you are calling and be ready to answer questions.
- 3. If questions need further research, tell them you'll get back to them.
- 4. Ask for their support/opposition for a specific bill if applicable.
- 5. Always be courteous and professional. Say thank you!
