## 5.1 BCC Volunteer Monitoring Initiative-V-STeM Data Collection

The Onset Hobo data logger at Freja Park was not monitoring data as it was not submerged in the water.

P. Van Dine and R. Parlee plan to meet on August 6, 2020 at 9:00 a.m. to test the Tidbit's response under water.

A future date will be set to check the Onset Hobo data loggers in Baker Brook and French Brook.

# **5.4 Plan Monthly Trail Work Parties**

R. Parlee walked the trail at Freja Park. Some of the barberry and multi flora rose has been cleared but the autumn olive is closing off part of the trail. The water bars need to be cleaned out and/or reinstalled. At the bottom of the Shenipsit trail there is an area that is being worn out by mountain bikes. The green blaze is missing on the bridge and some of the signs need to be reattached.

A. Bicknell proposed August 8, 2020, as a work day beginning at 9:00 a.m. Members will meet in the commuter lot by Freja Park with tools including loppers, a pick ax, shovels, rakes and gloves.

R. Parlee was in communication with Laurie Giannotti who runs the CT DEEP Recreational Trails and Greenway program. "All Trails" is the new initiative to document trails in the State. They discussed the usage of trails as bike paths and the possibility of paving trails for biking and the plan to install lighting in the tunnel.

In Bolton Notch State Park, the lower figure eight trail on the Tulip Tree Trail will be closed for a year or two due to downed trees. The trees were adversely affected by gypsy moth infestations.

R. Parlee, M. Rivers and P. Van Dine kayaked around Lower Bolton Lake and made a note of parcels that had lawns on the lakefront. P. Van Dine will share the data with R. Parlee. A future inventory may be made of retaining walls.

# 6.6 SCT, FBL and BLWCA Reports

The BCC members reviewed J. Laughman's report from the last SCT meeting. The need for an equity coach, tourism and composting were discussed.

The FBL is working with Northeast Aquatic Research as part of the STEAP grant. There are Koi fish in Middle Lake and fanwort is present. Middle and Lower Lakes have returned to their more traditional levels. The knowledge of both lakes is improving. The next FBL meeting will be held on August 19, 2020, at 6:30 p.m.

BLWCA met in late July. R. Parlee noted that there were two guest speakers from the North Central Conservation District including Executive Director Joanna Shapiro. There was a recommendation to increase the upland review area to 200 feet around the Atlantic White Cedar. The Towns of Bolton, Coventry, Tolland and Vernon need to come together to protect the lakes.

P. Van Dine made a motion to accept the clerk's invoice as presented. A. Bicknell seconded. The motion passed unanimously.
