## 4.0 Financial Report

## 4.1 Notch Pond Water Analysis Payment to Phoenix Environmental Laboratories

R. Parlee noted that P. Van Dine is looking into whether this payment should be applied to the last fiscal year budget or this year's budget.

#### 5.0 New Business

## 5.1 NEPARC 2023, Sharing the Landscape Conference

R. Parlee attended the NEPARC (Northeast Partners in Amphibian and Reptile Conservation) conference that was held at Wesleyan University. After the panel discussion, R. Parlee spoke with the facilitator who also served on the Mansfield Conservation Commission, Juan Sanchez and Hank Gruner and Michael Klemens, a herpetologist. This conference opened up a lot of questions. The panel included a developer who was conscious of environmental concerns and favored a pre-application meeting with land use commissions.

#### 5.2 Salamander Survey by Hank Gruner

On July 6, 2023, R. Parlee and A. Bicknell were at the headwaters of the Hop River where they identified two dusky salamanders and placed the newly acquired tidbit in the stream.

On July 26, 2023, Mr. Gruner again was joined by R. Parlee and A. Bicknell and they identified six dusky salamanders and four two-lined salamanders and they relocated the active tidbit to the vernal pool.

On August 4, 2023, the vernal pool in Bolton Notch State Park was the highest that R. Parlee and A. Bicknell have ever seen, especially at the southern end. R. Parlee was able to find and retrieve the tidbit that was tied to the rock and he downloaded the data so that P. Van Dine can update his records.

# 5.3 NRI-Mapping

R. Parlee shared two maps online. The first was a map of core forest put together by CLEAR (Center for Land Use Education and Research). The second was a map of Conservation Focus Areas put together by The Capital Region Plan of Conservation and Development. R. Parlee and P. Van Dine plan to learn QGIS for mapping purposes.

P. Van Dine offered to be Vice Chair and/or Treasurer for another term.

## 6.2 Notch Pond Litter from Culverts, Beavers, and Water Analysis Results

**Notch Pond Litter** – P. Van Dine and R. Parlee are trying to schedule a meeting with Pam Sawyer and Jim Rupert to discuss ways to remedy the litter problem in the culverts.

**Beavers** – There have been no signs of the beavers. We're not sure if they have moved on, been trapped illegally or are not visible when the commission members have been looking for them.

**Notch Pond Water Analysis Results** – R. Parlee noted that the results are nice to see. P. Van Dine had explained that when your well water is tested, there are parameters. He is researching to see if there are parameters for ponds. Eric Thomas at CT DEEP or the CT Federation of Lakes may be able to provide parameters.

## 6.3 Stream Temperature Monitoring

The correspondence regarding the salamander survey included the temperature monitoring data. Tidbits are in place in Bolton Notch State Park and the Nathan Hale Greenway. P. Van Dine will share the current locations of all hobos at the September meeting.

## 6.4 CACIWC Report

R. Parlee asked what topics the commission members would like to have discussed at the upcoming CACIWC meeting.

R. Parlee is interested in vernal pool conservation and encouraging conservation commissions to conduct Natural Resource Inventories that include Vernal Pool surveys.

A. Bicknell is interested in getting the public more involved in conservation and making the public aware of what conservation commissions do.

A Director of The National Oceanic and Atmospheric Association may be the keynote speaker.

The CACIWC conference will be held on November 11, 2023, at the Doubletree Hotel and Conference Center in Bristol.

M. Rivers feels that the 10-foot elevated boardwalk would be expensive. Trex or a similar material would be more durable and cost effective. Leaching into surrounding waterways could be an issue. A reinforced trail would be the lowest impact but the most durable.

A. Bicknell questioned if an elevated boardwalk would qualify as a project for bank erosion and if there is grant money available.

R. Parlee said that more information is needed as to what materials are proposed and more mapping is needed to see where they intend to install the boardwalk. R. Parlee shared this info with Bike Walk Bolton.
