1.0 Call Meeting to Order – Roll Call

Chairman R. Parlee called the meeting to order at 7:02 p.m.

2.0 Minutes Review of April 1, 2024, Regular Meeting

A. Bicknell made a motion to accept the minutes as presented. M. Rivers seconded. The motion passed unanimously 4:0:0.

He would like to know what data they'd like and where they would they like it from. The Blackledge or French Brook close to Tinker Pond may be better location for sampling. M. Rivers will follow up with SRWP.

5.4 Swapping of Stream Temperature Monitors & Additional VP Location

A. Bicknell and P. Van Dine offered to go to French Brook with R. Parlee tentatively on Saturday, May 18, 2024 at 10:00. They would meet at Peter's house.

Ed Pawlak asked Rod about a standing water wetland and the vernal pools in Bolton. 2025's Vernal Pool Day may be held at the vernal pool behind the library. P. Van Dine suggested that R. Parlee speak with Cameron Covill.

5.5 Calibration of ExStik II Conductivity/TDS/Salinity Meter

P. Van Dine has testing solution and he needs to run through the calibration technique. The ExStik should be calibrated just before it is going to be used. He will share his knowledge with the other BCC members. R. Parlee volunteered to bring his nitrate test kit to French Brook when the swap is done.

6.1 Results of Earth Day Celebration

A great time was had by all. The recycled paper notebooks for the kids were a big hit. A mini bio blitz was done. Many items were identified by the children. Marge Winters was a fantastic special guest. She has been invited to join the BCC on Trails Day.

6.2 Results of Recycling Program with All American Waste

A. Bicknell reported that the program was very well received. The presenter was very personable and explained the recycling process thoroughly. Anything less than 2 inches in length and height is not recyclable. Black plastic is also not recyclable. One of the young men that attended was very interested in recycling. The presenter from All American Waste was going to bring a recycling truck to his house to give him a ride. Another workshop may be planned for food waste or composting. R. Parlee will ask Brian Popovich for a copy of his Power point presentation. A. Bicknell suggested holding these workshops 2-3 times a year.

R. Parlee brought the giant paper open space map. He would like to have the BCC members come to the meetings at 6:30 p.m. to help to identify locations on the map.
