a. survey to businesses

Mr. Anderson will contact Mr. Kerr for the latest version of the survey to review and send out. The group briefly discussed that the purpose of the survey is reach out to businesses, and get an updated contact list to reach out to business owners to notify them of pertinent information and events. Mr. Anderson asked commission members to see if they can come up with questions to include on the survey for the next meeting. Mr. Anderson will also get all contact info compiled by Mr. Kerr.

Mr. Hathaway was not present to give a report.

B. EDC Website

Ms. Teller will request to have the link to the Route 6 Study added to the EDC webpage.

C. Branding Project/Welcome Signs

Ms. Teller shared with the group information on signs that were in the Route 6 Study. The information included a sample picture, along with recommendations on signage. Ms. Teller also included information that was part of the Route 44 Study on recommended signage. Ms. Teller will bring a map to the next meeting for the group to consider locations for signs.

Ms. Teller will add to the agenda "Training" for different webinars, meetings, etc. that would be useful to EDC. Mr. Anderson said he is usually available during the day to participate in some of the events. Ms. Teller also suggested participating in a webinar at the EDC Meeting.

Mr. Anderson reported he handed in all of the Code of Ethics Forms to the Town Clerk. Mr. Rich had already signed one for the BOE.

2. National Small Business Week

Mr. Anderson requested that "National Small Business Week" be added to the agenda in the future. The week takes place in May every year. Mr. Anderson would like to plan something for next year to support local small businesses.

Mr. Rich reported that he heard Bolton Pizza was recently sold and bought by a new owner. The group will reach out to them to see if they would like to do an Open House/Ribbon Cutting.
