Heritage Farm Commission Regular Meeting August 11, 2021

Alene Fiano, Rhea Klein, Beth Harney, Ann Maulucci, Bonnie Massey.. Building and grounds supervisor John Butrymovich was also in attendance with the Town Manager Jim Ruper (left at 2:40 after the discussion of the panels). Raymond Marrion and Cara Wraight were also not in attendance.

1. Call to order

Arlene called the meeting to order at 2:00 P.M.

2. Interpretive Signage

Wilderness Graphics panels were presented to the commission for review.

First Panel - French American Alliance

Our requirements were taken into consideration by Cindy Abaco from Wilderness Graphics and the panels were described as attention getting with straightforward wording and an accurate depiction of the theme of the panel. Cindy is waiting for authorization for the use of one of the photos, she will keep us informed.

Second Panel - March to Victory

Changes suggested are to focus more on Bolton by replacing the Lebenon encampment with the Camp 5,Bolton Heritage Farm site inserting and enhancing the farm photo with a you are here icon on the map.

Third Panel - With Open Arms

There was lengthy discussion on changes that might be made to this panel because there wasn't sufficient contrast between the photo and the sketch of the soldiers camping. Furthermore, the words "Then called the Rose Farm" needs to be removed, fine print for the dedication needs to be larger, verify the exact numbers of troops and support people that camped each day. Reword the paragraph to better explain that there were 4 encampments with 1,000 plus each time. As it reads there were 4,000 in one visit. In addition, the picture of Rev. Colton is believed to have been drawn by Ralph Earle who lived in Bolton. We would like this Bolton history added under the painting.

There was no QR Code shown on the panels that may be programmed later. The Commission would like to be able to add a website site link and information in the future.

Sarah Nelson will make suggestions regarding sign placement. Utilization of mockups will assist in the decision for placement of panels.

B. Update on Fund Raising/ Monday Night Yoga

Unfortunately, it rained lightly 2 hours prior to the 2nd event, and the grass never dried sufficiently to continue. We discussed the possibility of using a tarp to cover the grass if rain is forecasted in the afternoon to keep the grass dry for an evening class. The commission met with the Survey Planning Grant team at a special meeting on July 19, 2021. Arlene met with Sarah Nelson and Tom at the farm for a site visit and to view the interior of the barn. A followup letter was composed to reflect a mutual understanding of our goals in the immediate future and beyond. Arlene now sees the relevance of researching other farms to learn about their experiences in their commercial endeavors. Therefore, we will start working on site visits to the properties that were identified by Cara and Beth. Also we will use the questions that Sarah provided at the special meeting.
