Fire Commission Chairman John Morianos convened the Bolton Fire Commission meeting at 7:02 P.M. at the Bolton Fire House.

PAYMENT OF BILLS - None

COMMUNICATION FROM THE CHIEF -

- The Bolton Volunteer Fire Department (BVFD) responded to 35 emergency calls since the last meeting which included motor vehicle accidents on Route 6 and on Bolton Center Road, 63 Lynwood Drive, a boating accident in Vernon, 7 Meadow Rd which included a gunshot victim and many EMS calls.
- Budget: Discussion with the Board of Selectmen (BOS) on February 21, 2024 concerning
 Fire Commission budget submitted. BOS cut Training line item by \$4,000, Payroll line
 item by \$2,000 and a Lieutenant position. They increased the Proficiency Fund line
 item, however it will remain in the Proficiency Fund line item, not the Payroll items, as
 requested.
- The town's new 2023 Pierce fire apparatus, ET134, final cost came out to \$18,400 over budget after the total cost was estimated by the Chief back in 2015 during the Capital Project submissions. The BOS asked that the BVFD contribute \$5,000.00 from their budget to cover this expense.
- The town's 1993 E-One fire truck, ET334, has been retired and delivered to the Eastern CT Fire School in Willimantic after a decision made by the BOS.
- The new training building prop is nearing completion, with many thanks to the Bolton Greater Together Community Fund and the engineering and carpentry skills by DC Pereira and FF Cycenas.
- The current budget, 2023-2024, is at 23 % spent.
