ADOPTION OF MINUTES:

TRANSPORTATION STUDY:

CHA requested that the Council provide final comments on the existing conditions plan for the corridor at this meeting. Overall, the Council felt that the plan was well prepared and conveyed the concepts very well and the images were helpful.

Carmen reported on a meeting between DOT and Edith Prague regarding pavement issues that were of concern to a local citizen. The concerns appeared to be more aesthetic in nature.

RTE 6 PROJECT:

Scheduling a meeting date for the zoning subcommittee has been difficult. John will reach out again to the members via 'Doodle' for a June meeting.

All Council/Selectmen endorsements have been completed and the resolution sheet is being signed by the Towns.

An important next step is to schedule a meeting with the various State agencies, such as: DECD, DEP, DPH, Legislators, OPM, Regions, Metro Hartford Alliance. After the June legislative sessions seems to be reasonable.

John reported that he and Terri Hahn did a presentation of the Corridor Plan for the CRCOG Transportation Committee and it was well received. Efforts will be made to do a similar presentation to WINCOG.

USDA funding possibilities for sewer and water facilities were discussed.

It was agreed that the next two meetings should be dedicated to preparation for the presentation with the State agencies.

Eric briefly discussed a potential Transit Oriented Design Grant opportunity for the Council. It was agreed that the grant was not very applicable at the moment.

The Council discussed the use of STEAP funds to assist with gateway improvements to demonstrate visible enhancements to the corridor. Some of the corridor towns have already committed to other projects at this time. John volunteered to pursue potential costs for these improvements.
