### 4. Consider and Possibly Act on Congressional Directed Spending Grants.

Most of this money requires a match but they would really like to give Bolton some money as Bolton has not received any of this grant money.

### Projects:

- A. Waterline match is 20% under the state revolving fund
  - we're looking at \$2.7 million for this project
- B. Herrick Park soccer fields, BHS soccer field/track and Fire Department master plan
  - if this budget passes we will have \$210,000 in Capital for Herrick Park
  - we are only short \$90-100,000 for Herrick Park
  - this \$\$ comes out of an agricultural account we can receive up to 55% and then rest we are responsible for
  - T HUD full funded grant (very competitive)

**Motion:** M. Eremita moved that the Board of Selectmen apply for Herrick Park and the Fire Department master plan under the agricultural grant and the high school soccer field/track under the T HuD non-matching grant.
