
All of the analyses, findings, data, and recommendations contained within this report are the exclusive property of The Town of Bolton.

TABLE OF CONTENTS







GreatBlue Research, Inc. (GreatBlue) is pleased to present the results to a 2014 Residential Survey.

The survey included interviews with 169 residents living in Bolton, CT.

The survey began with a screener to ensure eligibility. Respondents qualified to answer the survey if they were one of the heads of their household and eighteen years of age or older.

This report summarizes statistics collected from 100 resident interviews conducted between August 13th and August 20th, 2014 and an additional 69 online interviews conducted throughout the month of September.

The 2014 Residential Survey included the following areas for investigation:

- Residents' overall satisfaction with town services (i.e. parks and recreation, public transportation, new developments, the school system, safety, tax expenditures);
- Perceptions of the current quality of life;
- > Opinions of any upcoming, potential major projects;
- Preferred methods of communication;
- Satisfaction and awareness of government services;
- Reasons why people choose a particular municipality, what they like, changes they would like to see; and
- Demographics.

Following this Introduction, Section II contains and explains the methodologies employed in completing this 2014 Residential Survey, the margin for error and the confidence level for the statistics collected.

Section III contains data tables presenting 2014 data for each question both in the composite form as well as segmented by method of capture (telephone and web).

Section IV is Appendix I containing a copy of the survey instrument utilized.





GreatBlue research staff completed 169 surveys using a quantitative design among residents living in Bolton. Respondents were eighteen years of age or older and one of the heads of their household. The Town of Bolton provided GreatBlue with an updated list of its registered voters.

Survey input was provided by the Town of Bolton team and actual wording of each question may be found in the Appendix of this report.

Survey design at GreatBlue is a careful, deliberative process to ensure fair, objective and balanced surveys. Staff members, with years of survey design experience, edit out any bias. Further, all scales used by GreatBlue (either numeric, such as one through ten, or wording such as strongly agree, somewhat agree, somewhat disagree or strongly disagree) are balanced evenly. And, placement of questions is carefully accomplished so that order has minimal impact.

Residents were contacted between 5:00 p.m. and 9:00 p.m. weekdays. The survey was conducted between August 13th and August 20th, 2014. In addition, residents had the ability to access the survey online throughout the month of September

GreatBlue used a callback procedure to ensure the randomness of the sample and to reduce nonresponse bias. When a randomly selected resident was not available during the first telephone contact, additional callbacks were made in order to complete the interview. A demographic profile of respondents may also be found in the Appendix of this report.

All interviews were conducted from GreatBlue headquarters located in Cromwell, Connecticut. All facets of the study were completed by GreatBlue's staff. These aspects included: survey design, sample design, pre-test, fielding, coding, data entry, editing, validation, verification, computer analysis, analysis and report writing.

Statistically, a sample of 169 surveys represents a margin for error of +/-7.5% at a 95% confidence level.


In theory, a sample of 169 residents will differ no more than +/-7.5% than if all Bolton residents were contacted and included in the survey. That is, if random probability sampling procedures were reiterated over and over again, sample results may be expected to approximate the larger population values within plus or minus 7.5% - 95 out of 100 times.





QUALITY OF LIFE

 Almost three-quarters of respondents (72.8%) reported living in Bolton for 11 years or more. Half of respondents (52.7%) have been living in Bolton for at least 25 years. This suggests a high level of commitment to the Town of Bolton.



- All respondents (100.0%) reported the overall quality of life in Bolton is either "very good" (58.0%) or "good" (42.0%).
 - While this is impressive, two-thirds of respondents (67.5%) reported that quality of life has shown "no change." Efforts should be made to show residents that quality of life is "improving."
- The most important characteristics of Bolton in contributing to a positive quality of life were largely related to the character of the town, including, but not limited to, town services:
 - Peace and quiet (99.4%);
 - Small town character (97.6%);
 - **Open space (96.4%);**
 - School system (95.9%);
 - Police, Fire Protection & Emergency (95.3%); and
 - Taxes (95.3%).




TOWN SERVICES

The overwhelming majority of respondents (97.6%) agreed that "Bolton's fire services are adequate." While still strong, a slightly lower percentage of respondents (79.9%) agreed that "Bolton's police services are adequate." Efforts should be made to either improve police services or improve the perception of police services.

GOVERNMENT

- An even divide was reported by respondents who "agreed" the property taxes are fair (48.5%) and those who "disagreed" (50.9%)
 - While 49.7% of respondents would not provide the Town with an option that would make them willing to pay higher taxes, others requested that Bolton "improve the school system" (17.8%), "bring in new business" (7.1%), or "stay rural/more open space" (6.5%) in order to pay higher taxes.




In further support of this, while the majority of respondents (85.8%) agreed with the statement that "the Town of Bolton provides the range of services needed in the community," only 16.6% reported they "strongly agree." This may suggest that while a variety of services are offered, each individual service may have some areas of improvement.



OPEN SPACES & PROTECTING RESOURCES


- When respondents were read a list of statements about protecting resources that are important to the community, the majority of respondents (85.2%) agreed that "Bolton should strive to preserve more open space areas."
- However, less than half of respondents (46.7%) agreed that they "would be willing to pay a small amount each year on taxes which would be dedicated to purchasing open space."
 - This suggests that residents believe the current amount of available open space should be preserved. However, they may not see a need to increase the amount of open space.





MANAGING DEVELOPMENT & UPCOMING PROJECTS

- ➢ When read a list of statements about balancing the Town development with current appeal and character of the town, almost all respondents (95.3%) were in agreement that "any improvements to the buildings in the Town Center where the Town Hall is should strive to maintain the historical character of the area."
- The large majority of respondents (92.9%) also agreed that "the design of business buildings is an important consideration in any new development in Bolton."
- This is further supported by the fact that only one-quarter of respondents (37.3%) agreed that "Bolton should consider utilizing town property for a lunch/café restaurant" as part of the Town Center."
 - Based on this feedback, should there be upcoming projects involving a lunch/café restaurant to be built in the Town Center, the design of the restaurant should reflect the historical character.








QUALITY OF LIFE

Respondents were initially asked how long they have been living in Bolton. As presented below, almost three-quarters of respondents (72.8%) reported living in Bolton for at least "11 to 25 years" (20.1%) or "25 years or more" (52.7%). This suggests a high level of commitment to the town of Bolton.



Next, researchers asked respondents the reasons why they first chose to live in Bolton.

The table below presents the results. Multiple responses were accepted.




Impressively, all of the respondents (100.0%) reported the overall quality of life in Bolton is either "very good" (58.0%) or "good" (42.0%).

In a follow-up question, respondents were asked to indicate whether they thought the quality of life in Bolton is improving, not changing, or declining. Two-thirds of all respondents (67.5%) reported the quality of life has shown "no change;" while 81.0% of phone respondents reported "no change" in the quality of life.

While "no change" may be neutral, there is equal opportunity for those 67.5% of respondents to convert to "improving" or "declining," thus efforts should be made to convert the "no change" respondents to "improving" respondents.





In an open-ended response format, respondents were asked to describe the most important issue they felt was facing the Town of Bolton today.

The most frequently reported issues were "taxes" (46.7%) and the "school system" (21.3%).

Next, respondents were asked to rate services or characteristics in Bolton on how important each are in contributing to a **positive quality of life**. The table below presents the total "important" ratings of one (1), meaning "very important," and two (2), meaning "somewhat important."

Impressively, six (6) of the thirteen (13) characteristics received a rating of at least 95.0%. The three (3) most important characteristics were largely comprised of the environment of living in Bolton (i.e., town character, open space, peace and quiet); while the least important characteristics are secondary needs that aren't necessary to exist in a town (i.e., shops, stores and restaurants).

Thinking about a variety of Town services provided in Bolton, respondents were then asked to indicate how strongly they agree with each.


As presented in the following table, the highest level of respondents (97.6%) agreed that "Bolton's fire services are adequate." The lowest level of agreement was reported for the statement "There is adequate space in Town buildings for public meetings, staff meetings, senior services or social services and recreation" (76.3%).

GOVERNMENT

When asked about the fairness of property taxes for the services provided by Bolton, slightly less than half of respondents (48.5%) reported they either "strongly agree" (7.7%) or "somewhat agree" (40.8%) that the taxes are fair. The other half of respondents (50.9%) reported they either "somewhat disagree" (32.0%) or "strongly disagree" (18.9%).




Respondents were then read the following statement: "I would be willing to pay slightly higher taxes now if it meant the ability for the town to ______." and asked to fill in the blank

While 49.7% of respondents "wouldn't complete the statement," the most frequently reported willingness to pay higher taxes would be if the Town had the ability to "improve the school system" (17.8%). The responses reported below may help convert the respondents who "disagree" that taxes are fair.




Respondents were also read the following statement: "*The Town of Bolton provides the range of services needed in the community*." When asked to indicate their level of agreement with the statement, the majority of respondents (85.8%) reported they either "strongly agree" (16.6%) or "somewhat agree" (69.2%).






When asked if they felt the administration and enforcement of the Town's building and development regulations is fair, more than three-fifths of respondents (63.9%) reported "yes" it is.



In a similar question, respondents were asked to indicate if they believed the administration and enforcement of the Town's building and development regulations is <u>strong enough</u> to preserve the Town's character and resources. A similar percentage of respondents (68.0%) reported "yes."



It is important to note, that a much higher percentage of online respondents provided "don't know/unsure" responses to the previous two questions. This may imply a difficulty understanding the context of the question, without the aid of a researcher.



OPEN SPACES & PROTECTING RESOURCES

All respondents were then read a list of statements about protecting resources that are important to the community and asked to indicate how strongly they agree with each.

More than four-fifths of respondents (85.2%) agreed that "Bolton should strive to preserve more open space areas." However, the statement which received the least agreement was "I would be willing to pay a small amount each year on taxes which would be dedicated to purchasing open space" with less than half (46.7%) of respondents agreeing.

This may suggest that residents are satisfied with the amount of open space already available and want them to be preserved. However, they may not feel an increase in the amount of open space is needed.

MANAGING DEVELOPMENT & UPCOMING PROJECTS

Finally, respondents were read a list of statements about balancing Town development with the current appeal and character of the Town as it stands. They were asked to indicate how strongly they agree with each.

Almost all respondents agreed that "any improvements to the buildings in the Town Center where the Town Hall is should strive to maintain the historical character of the area" (95.3%) and "the design of business buildings is an important consideration in any new development in Bolton" (92.9%).

However, less than two-fifths (37.3%) agreed that "Bolton should consider utilizing town property for a lunch/café restaurant" in the Town Center. This is supported by the previous low level of importance of "restaurants" contributing to the positive quality of life.

INTERPRETATION OF AGGREGATE RESULTS

The computer processed data for this survey is presented in the following frequency distributions. It is important to note that the wordings of the variable labels and value labels in the computerprocessed data are largely abbreviated descriptions of the Questionnaire items and available response categories.

The frequency distributions include the category or response for the question items. Responses deemed not appropriate for classification have been grouped together under the "Other" code.

The "NA" category label refers to "No Answer" or "Not Applicable." This code is also used to classify ambiguous responses. In addition, the "DK/RF" category includes those respondents who did not know their answer to a question or declined to answer it. In many of the tables, a group of responses may be tagged as "Missing" – occasionally, certain individual's responses may not be required to specific questions and thus are excluded. Although when this category of response is used, the computations of percentages are presented in two (2) ways in the frequency distributions: 1) with their inclusion (as a proportion of the total sample), and 2) their exclusion (as a proportion of a sample sub-group).

Each frequency distribution includes the absolute observed occurrence of each response (i.e. the total number of cases in each category). Immediately adjacent to the right of the column of absolute frequencies is the column of relative frequencies. These are the percentages of cases falling in each category response, including those cases designated as missing data. To the right of the relative frequency column is the adjusted frequency distribution column that contains the relative frequency distribution excludes the missing data. For many Questionnaire items, the relative frequencies and the adjusted frequencies will be nearly the same. However, some items that elicit a sizable number of missing data will produce quite substantial percentage differences between the two columns of frequencies. The careful analyst will cautiously consider both distributions.

The last column of data within the frequency distribution is the cumulative frequency distribution (Cum Freq). This column is simply an adjusted frequency distribution of the sum of all previous categories of response and the current category of response. Its primary usefulness is to gauge some ordered or ranked meaning.
