# **B.** Fee Schedule

The board discussed how the current fee schedule for quarterly usage and for permits/connections is not covering current operational costs for the authority. In addition, no funding is being set aside for capital expenditures/replacements based on the current cash flow.

A motion was made by R.Hayes, seconded by D.Champagne, to set a Public Hearing for July 25, 2018 at 7:00 P.M. at the Vernon Town Hall for public comment on the following proposed revised Schedule of Rates, Charges and Fees effective October 1, 2018:

## I. Sewer Use Rates

#### A. Rate

Effective October 1, 2018 - \$100.00 per quarter per EDU

## B. Use Charges

Use charges will be levied quarterly in the months of July, October, January and April. All users shall be charged for sewer service based upon the number of EDU's or fractions thereof as assessed by the BLRWPCA.

Motion unanimously passed.

## C. Rules and Regulations

J.Stille reported that no specific issues or concerns have been noted as to the BLRWPCA Rules and Regulations but suggested members review documents to determine if any changes are warranted.

# **D.** Status Report on Operations

J.Stille reported that two years ago our insurance consultant USI was asked to review the BLRWPCA coverage and they were asked to again review it. Recently we had included a message on the back of our quarterly bills about contacting us during prolonged power outages. Residents were encouraged to sign up for Bolton's emergency notification system as well.

# E. Expansion to Sewer Service Area:

# **Town of Coventry**

Currently, the engineers are monitoring our systems flow and pressure to determine the capability of our system to expand into Coventry on Route 44. All indications show this to be quite feasible. BLRWPCA will need to determine if and how to proceed with the Town of Coventry for the expansion. The Town of Bolton supports this cooperative effort with Coventry.
