Attorney Zozula is representing Enterprise. Enterprise's lease at its current location is not being renewed by the property owner and are seeking another location within the City of Revere. Enterprise is interested in relocating to the HB District on Squire Road. Rental Car Facilities are not allowed in the HB District and therefore are applying for a zoning ordinance amendment to allow for Rental Car Facilities in the HB District with certain conditions and by Special Permit.

Mr. Zambuto cited spot zoning and questioned whether Enterprise could even apply for a zoning amendment since Enterprise is not the record owner of the property. Mr. Zambuto and Councillor Fiore questioned where the vehicles are registered citing excise tax concerns and out-of-state registration concerns.

Several Councillors including Rotondo, McKenna, Keefe, and Rizzo cited opposition to the proposed use in the HB District as it is not their vision for Squire Road. The Councillors would rather see the highest and best use for this area like hotels, restaurants, or other retail uses.

Councillor Cogliandro was a proponent of the zoning amendment citing an increase in tax revenue to the City. Additionally, most of Enterprise's clients are local residents.

The proponents provided a summary of the proposed project and reiterated that the proposed residential units will be condominiums. Mr. Vienneau also stated that he will be providing a traffic study to the Council for consideration.

The opponents cited several reasons in opposition which included the proposed building height; the number of proposed units; noise generated from roof top pumps, construction, and trash pickup; insufficient water, sewer, and pump station infrastructure; traffic, parking issues, dog waste, and trespassing through private property to access the public bike path. The proposed height of the building is especially concerning for neighbors due to potential shadows cast on their pools. In response, Councillors McKenna, Rotondo, and Serino requested that the applicant conduct a shadow study.

Councillor Serino who represents Ward 6 requested that the applicant holds regular neighborhood meetings during the course of the project. He further stated that if approved, the project will enhance the outdated property, benefit the neighborhood directly through the Community Improvement Trust Fund, and provide much needed housing suitable for first-time homebuyers.

Councillor Fiore indicated that he believes the proposed number of units is too many and has concerns about visitor parking spilling over into the adjacent streets. Councillor Keefe cited concerns over dumpster pick-up times and location, parking, traffic, shadows, and sewer infrastructure and looks forward to discussing these issues in his Zoning Sub-Committee.

The Committee of the Whole met on Monday, February 28, 2022 at 5:00PM in the City Councillor Joseph A. DelGrosso City Council Chamber. Committee members present were Councillors Cogliandro, Fiore, Keefe, McKenna, Morabito, Novoselsky, Rizzo, Serino, Silvestri, and Council President Visconti.

Paul Fahey, Election Commissioner was present and addressed the Council. He agreed with many of the Councillors' comments regarding communication, outreach, and signage.

Many Councillors also want to make voting easier for seniors whether that be through early voting, supervised absentee voting, or if feasible, free public transportation to the polls. Commissioner Fahey did note that absentee voting would be the more efficient option than bussing.

Both Representative Turco and Giannino agreed with consolidating precincts into as few polling locations as necessary and clearly marking voting locations. Doing so will help make voting easier for our residents.

WHEREAS: Gibson Park, Costa Park, and Harmon Park is dedicated to park and recreation purposes under M.G.L. c.45, Section 3; and

WHEREAS: The renovation of the playground safety surfaces from playground mulch to poured in place rubber to accommodate individuals with mobility challenges provides enhanced accessibility advancing the cities goals for equity and inclusion for all park users.

WHEREAS: The Executive Office of Energy and Environmental Affairs is offering

reimbursable grants to cities and towns to support the preservation and restoration of urban parks through the Parkland Acquisitions and Renovations for Communities (PARC) grant program; and

WHEREAS: The Costa Park, Harmon Park Gibson Park renovation project will cost a total of \$485,208. The amount of \$329,942 will be reimbursed to the City in PARC grant funds. The council agrees to appropriate 485,208 for the project and after the completion of the project and the project is paid in full the city will then be eligible for reimbursement of the PARC grant funds.

I. AN ORDINANCE FURTHER AMENDING TITLE 12 OF THE ORDINANCES OF THE CITY OF REVERE.

SECTION 1. Title 12 of the Revised Ordinances of the city of Revere is hereby amended by inserting the following new chapter and sections:

Chapter 12.18 - DRAIN LAYERS

12.18.010 – Definition.

"Drain layer" is a general term applied to a licensed professional, engaged in the business of installing sanitary sewer pipes, water distribution pipes, stormwater pipes, natural gas pipes, electric conduit, including geotechnical subsurface exploration, and any/all underground and subsurface utilities. Such utilities include main line pipes as well as public or private service line pipes, and all related connections and appurtenances.

12.18.020 – Approval; applications; licensing.

- A. Consistent with chapter 13.08, all drain layers must be licensed and/or approved by the director of public works and the city engineer prior to commencing any work within the city of Revere. The director of public works and the city engineer may license such drain layers as apply and are found competent. No person other than a licensed drain layer shall construct, repair, otherwise connect to or excavate for such purpose any utility within the City's right of way nor perform any type of subsurface exploration and/or boring of any kind.
- B. All applications for the construction, repair, or alteration of utilities for private use within the City's right of way, and their entrance into common utilities, shall be made to the director of public works, and shall be in such form as he/she shall prescribe, and shall be approved by the city engineer. All such utilities for private use within the City's right of way and their entrances into common utility systems shall be constructed, connected, maintained, and kept in repair by a licensed private drain layer hired or employed by the applicant in such manner as the director of public works and/or city engineer may from time to time determine. The cost of any work so constructed, maintained, or repaired shall be paid by the applicant therefor.

As you are aware, I represent Mr. Paul Ferragamo, in connection with his offer to donate his land on Revere Beach Parkway, identified as MBP 4-90-002, to the city for conservation purposes.

By way of background, the item previously was docketed as City Council Item 21-382. Procedurally, the Conservation Commission unanimously approved the acceptance of the donation in May, 2021. The City Council initially heard the matter on November 8, 2021. The council identified issues to be addressed and referred our request to Ways and Means. The legislative term expired.

Mr. Ferragamo has asked me to renew his offer. Accordingly, I ask that you transmit this communication to be received by the council and scheduled for hearing. Also through this letter my client would like to supplement the prior testimony before the council by reporting that he has conducted a site examination with his land development expert and has been in communication with the abutting townhouse complex. The field survey reveals that the lot has enough land to possibly support pursuit of the 6000 sq. foot residential overlay to site a modest home or consider a telecommunications facility under the federal telecommunications act. The neighbors made it clear to my client that they prefer the land be donated in contrast to any development. I do re-emphasize that Mr. Ferragamo prioritizes the donation disposition of the land in contrast to a development effort.

As to the issues identified in November by the ward councilor there was a single shopping cart to be removed from the large tract and the balance of the land is virgin in terms of natural vegetation and growth. There was the suggestion that Mr. Ferragamo thin the overgrowth but that would require a Conservation Commission filing of a Notice of Intent and acquisition of an Order of Conditions, the exercise of which would only make business sense if he were to seek the development options.
