Public Hearings:

1. The Traffic Commission will hold a public hearing to address changes to the parking ordinances a complete list of these changes will be posted in City Hall. See attached

2. Schedule XII of Title 10 Fire Lanes is hereby amended by adding:

Location	Side	Length
Naples Road	both sides	from Route 107 to 405 American Legion Highway (rear)

3. Schedule XIX of Title 10 ON STREET PARKING METER ZONES by removing the first three meters on the westerly side of Broadway at Revere Beach PKWY.
4. Schedule IX of Title 10 Resident Parking Streets – 24 Hour Enforcement be amended by adding:
Chamberlain Ave. (odd side), Delano Ave. (odd side), Alden Ave. (odd side), Bickford Ave. (odd side), Lancaster Ave. (odd side), Whitin Ave. (odd side), Fowler Ave. (odd side), Bateman Ave. (odd side), Lynnway, Witherbee Ave (odd side), Goodwin Ave. (odd side), Wadsworth Ave. (odd side).
5. That Schedule VIII of Title 10 Parking Restrictions Generally be amended as follows:
 - a. Witherbee Avenue is hereby amended by deleting “both” and inserting in place thereof “northerly”.
 - b. Wadsworth Avenue is hereby amended by deleting “both” and inserting in place thereof “northerly”.
 - c. Goodwin Avenue is hereby amended by deleting the entry for “both sides, entire length, no parking either side”

6. Amend Schedule XI of Title 10, Handicapped Persons Parking Areas, by adding:

21 Dedham Street

41 Taft St

54 Eastern Ave

7. Amend Schedule VIII of Title 10 Parking Restrictions Generally by allowing parking at the Point of Pines Yacht Club along their fence and property line with valid parking stickers.

Requests:

1. Councilor Keefe requests to amend the parking ordinance by adding 77-116 Park Ave to resident permit parking 24/7.
2. Follow up on request by Councilor Powers from the March Traffic Commission Meeting.

That the Fire Chief be requested to examine the width of the streets on the Riverside to see if allowing parking on one side of the street is feasible, except for Mills Avenue.

The site visit was completed on 04-21-21. It was determined that the average street width is 23'10". There are conflicting signs in the neighborhood (No Parking and Street Sweeping). Almost all of the streets in the area had vehicles parked on either one or both sides. The Ladder Truck could fit down the street with cars parked on one side however it could not fully set up properly if needed. (out riggers on sidewalk not the street). This area is listed in the City Ordinances as No Parking Anytime.
