## Traffic Commission Agenda August 17, 2023

Notice is hereby given in accordance with the provisions of Chapter 185 of the Acts of 1983, and Chapter 13 of the Acts of 1984, that the City of Revere Traffic Commission will conduct a Public Hearing on August 17, 2023 at 5:00 p.m. in the City Councillor Joseph A. Del Grosso Council Chambers of Revere City Hall relative to the following proposed amendments to the parking and traffic regulations of the City of Revere:

## Public Hearing

1. Continued discussion regarding traffic improvements for the Suffolk Downs development in Revere. The following pedestrian and traffic safety improvements will be discussed and voted on:

Amend Schedule V of Title 10, One Way Streets - A single block of Harris Street between Winthrop Avenue and Seawall Street will be converted from two-way to one-way. This change is proposed to improve signalized intersection operations and reduce neighborhood traffic.

## **Requests:**

1. Amend Schedule IV of Title 10 of the revised City Ordinance of the City of Revere by adding Stop Signs as follows:

Location	Direction
Malden Street	Westbound Traffic at Newhall Street
Malden Street	Eastbound Traffic at Newhall Street
Newhall Street	Northbound Traffic at Malden Street
Newhall Street	Southbound Traffic at Cushman Street

- 2. Traffic Calming Measures by adding:
- a. Add raised crosswalks/speed table at Hall's Corner on Malden Street in front of Vinny's Market
- b. Place traffic calming measures in strategic locations from Washington Avenue though the length of Malden street to help slow the speed of motorists.

- 3. Schedule VIII of Title 10 Parking Restrictions Generally by adding a 15 minute parking spaces on the East side of Walnut Ave at the corner of 104 Shirley Ave next to the Laundromat.
- 4. Title 10 Chapter 10.36 Section 10.36.065 of the revised ordinances of the City of Revere is hereby created by inserting the following new section in its entirety. Request an ordinance establishing free parking for individuals with Veteran and Military License Plates.

10.36.065 Fees - Veterans Parking.

The City of Revere shall permit any individual with the following Veteran and Military license plates to park for free at any on or offstreet metered City of Revere parking space, or any City of Revere owned surface lot space requiring payment via kiosk or using appbased payments:

- a. Veteran
- b. Bronze Star
- c. Silver Star
- d. Purple Heart
- e. Medal of Honor
- f. Legion of Valor
- g. Pearl Harbor Survivor
- h. Distinguished Flying Cross
- i. Ex-POW
- j. Medal of Liberty
- k. Disabled Veteran
- *l.* Gold Star Family

The provisions of this section apply only to parking meter fees and do not waive any other regulations governing a parking space, including but not limited to time limits, no-parking restrictions, handicap parking requirements, fire-hydrant requirements, tow zones, street sweeping, and resident permit-parking areas.
