Public Hearings:

Notice is hereby given in accordance with the provisions of Chapter 185 of the Acts of 1983, and Chapter 13 of the Acts of 1984, that the City of Revere Traffic Commission will conduct a Public Hearing on October 24, 2019, 2019 at 4:00 p.m. in the City Councilor Joseph A. Del Grosso Council Chambers of Revere City Hall relative to the following proposed amendments to the parking and traffic regulations of the City of Revere:

1. Amend Schedule VIII of Title 10 Parking Restrictions Generally by removing:

3. Amend Schedule XVI of Title 10 Service Zones by adding:

43 Nahant Ave.

4. Amend Schedule XI of Title 10 Handicapped Persons Parking Areas by adding:

70 Florence Ave
49 Constitution Ave
40 Constitution Ave

5. The Mayor request the Traffic Commission to review the speed limit on Rumney Road from Broadway to Patriot Parkway, and lower the limit to 20 MPH in the interest of public safety.

Requests:

1. Amend Schedule XI of Title 10 Handicapped Persons Parking Areas by adding:

287 Beach Street
112 Cooledge Street
15 Hutchinson Street
12 Arnold Street

2. Amend Schedule IV of Title 10- Isolated Stop Signs by adding:

Arcadia St. for northbound traffic at Argyle St
Arcadia St. for southbound traffic at Argyle St.
Argyle St. for eastbound traffic at Arcadia St.

3. Amend Schedule IX of Title 10- Resident Parking Sticker Areas by adding:

- a. Central Ave. both sides for the entire length Monday through Friday from 8:00am-5:00pm
- b. Webster Street both sides from Winthrop Ave to Crescent Ave.

4. Request from Councilor McKenna that the Orchard Ave. triangle be reconfigured to one way coming up from Crescent Ave and one way going down to Crescent Ave.

5. Councilor McKenna requests a right turn on red be allowed at State Rd and Winthrop Ave.

6. Councilor McKenna requests No Parking Here to Corner signs be placed on Mill St. at Beach St. both sides 20 Feet from the intersection.

7. Separate Lane lines on Winthrop Avenue from DiMino's Subshop on to the corner of MBTA. Two lines, one straight with left arrows and one arrow going right.
