The Zoning Map of the City of Revere is hereby amended by changing the zoning district designation of Map Block and Parcel 3-23-2A from the Residential B District to the Technology Enterprise District. 21. 23-142 Motion presented by Councillor Visconti: That the Acting Mayor request a representative from HYM or a representative from The Summer Concert Team to appear before the City Council to discuss the weekend traffic plans during the concerts. 22. Motion presented by Councillor Silvestri: That the Acting Mayor request the <u>23-143</u> Chief of Police to appear before the City Council to discuss the Revere Police Department and Massachusetts State Police plans in place for crowd control, riot control, or mass shootings at events and/or large crowds specifically at Revere Beach. Additionally, that the Chief of Police provide a response as to why Revere Beach was not closed and cleared immediately after two people were not and several other people were injured from assaults. 23. Motion presented by Councillor Visconti: In response to the shootings which 23-144 occurred over Memorial Day weekend, that the Acting Mayor appear before the Revere City Council to explain what exactly, if any, was the public safety plan that was put in place over the Memorial Day weekend to prepare for such an anticipated busy weekend and what is the public safety plan moving forward to

keep our residents safe.

- Motion presented by Councillor Serino, President Pro Tempore McKenna: That the City Council order to a public hearing the following amendment to Section 8.04.090 of the Revised Ordinances of the City of Revere relative to use of disposable plastic bags at retail business establishments: Section 1. Section 8.04.090(C) of the municipal ordinances is hereby amended by adding the following sentence at the end of the section, "Stores that are twenty thousand square feet or larger shall not charge a fee to patrons for a recyclable paper bag alternative."
- 26. <u>23-147</u> Motion presented by Councillor Silvestri: That the City Council award a Certificate of Merit to Sgt. Michael Travato for his leadership on Sunday, May 28, 2023. Sgt. Travato's clear and concise command and control directly lead to the arrest of the five individuals who were suspects in the shooting on Revere Beach.

MassPort will undertake a major safety and pavement rehabilitation project for Logan Airport's longest runway and will inudate Revere and especially Beachmont for 100 days. MassPort has been in communication with Winthrop and East Boston, but not Revere.
