Public Works Sub-Committee Report

Councillor Keefe awarded Certificates of Merit to the recipients on behalf of the City Council

The Public Works Sub-Committee met on Monday evening, March 14, 2022 at 5:00PM in the City Councillor Joseph A. DelGrosso City Council Chamber, 281 Broadway, Revere, MA 02151. Committee members present were Councillors Cogliandro, Morabito, Visconti (exofficio), and Chairman Novoselsky. Councillors Rizzo and Rotondo were absent.

22-049 An Ordinance Further Amending the Revised Ordinances of the City of Revere Relative to Curbside Collection Time for Trash.

During the initial public hearing on February 28, 2022, Councillor Rizzo offered an amendment to the ordinance to set the trash pickup time to 4:00PM year round instead of alternating winter and summer months. This amendment was well received by the Public Works Sub-Committee. Councillor Morabito suggested that the pickup time be rolled back an additional hour to 3:00PM to accommodate hospitality industry workers who leave for work early and get home late.

Paul Argenzio, Superintendent of Public Works did not see any issues with the time change and was in favor of the amendment.

Attorney Even Pilavis addressed the City Council on behalf of his client. He is re-submitting his request to the Council to consider the donation. Mr. Ferragamo has asked me to renew his

offer. Accordingly, I ask that you transmit this communication to be received by the council and scheduled for hearing. Also through this letter my client would like to supplement the prior testimony before the council by reporting that he has conducted a site examination with his land development expert and has been in communication with the abutting townhouse complex. The field survey reveals that the lot has enough land to possibly support pursuit of the 6000 sq. foot residential overlay to site a modest home or consider a telecommunications facility under the federal telecommunications act. The neighbors made it clear to my client that they prefer the land be donated in contrast to any development. I do re-emphasize that Mr. Ferragamo prioritizes the donation disposition of the land in contrast to a development effort. As to the issues identified in November by the ward councilor there was a single shopping cart to be removed from the large tract and the balance of the land is virgin in terms of natural vegetation and growth. There was the suggestion that Mr. Ferragamo thin the overgrowth but that would require a Conservation Commission filing of a Notice of Intent and acquisition of an Order of Conditions, the exercise of which would only make business sense if he were to seek the development options.





I. AN ORDINANCE FURTHER AMENDING TITLE 12 OF THE ORDINANCES OF THE CITY OF REVERE.

SECTION 1. Title 12 of the Revised Ordinances of the city of Revere is hereby amended by inserting the following new chapter and sections:

Chapter 12.18 – DRAIN LAYERS

12.18.010 - Definition.

"Drain layer" is a general term applied to a licensed professional, engaged in the business of installing sanitary sewer pipes, water distribution pipes, stormwater pipes, natural gas pipes, electric conduit, including geotechnical subsurface exploration, and any/all underground and subsurface utilities. Such utilities include main line pipes as well as public or private service line pipes, and all related connections and appurtenances.

12.18.020 - Approval; applications; licensing.

A. Consistent with chapter 13.08, all drain layers must be licensed and/or approved by the director of public works and the city engineer prior to commencing any work within the city of Revere. The director of public works and the city engineer may license such drain layers as apply and are found competent. No person other than a licensed drain layer shall construct, repair, otherwise connect to or excavate for such purpose any utility within the City's right of way nor perform any type of subsurface exploration and/or boring of any kind.

B. All applications for the construction, repair, or alteration of utilities for private use within the City's right of way, and their entrance into common utilities, shall be made to the director of public works, and shall be in such form as he/she shall prescribe, and shall be approved by the city engineer. All such utilities for private use within the City's right of way and their entrances into common utility systems shall be constructed, connected, maintained, and kept in repair by a licensed private drain layer hired or employed by the applicant in such manner as the director of public works and/or city engineer may from time to time determine. The cost of any work so constructed, maintained, or repaired shall be paid by the applicant therefor.

II. AN ORDINANCE FURTHER AMENDING TITLE 13 OF THE ORDINANCES OF THE CITY OF REVERE.

SECTION 1. Title 13, Chapter 13.08, Section 13.08.270 of the Revised Ordinances of the city of Revere is hereby amended by deleting this section in its entirety and inserting in place thereof the following:

13.08.270 - Sewer layer; drain layer.

See 12.18.010.

SECTION 3. Title 13, Chapter 13.08, Section 13.08.300 of the Revised Ordinances of the city of Revere is hereby amended by deleting this section in its entirety and inserting in place thereof the following:

13.08.300 - Director of public works.

"Director of public works" refers to the head of the public works department of the city or his or her authorized agent, deputy or representative.

SECTION 3. Title 13, Chapter 13.08, Section 13.08.355 of the Revised Ordinances of the city of Revere is hereby amended by deleting the words in the first sentence "by the city engineer," and inserting in place thereof "by the director of public works and the city engineer."

SECTION 4. Title 13, Chapter 13.08, Section 13.08.360 of the Revised Ordinances of the city of Revere is hereby amended by deleting the words "superintendent of public works" throughout and inserting in place thereof the words "director of public works."

SECTION 5. Title 13, Chapter 13.08, Section 13.08.360 of the Revised Ordinances of the city of Revere is hereby amended by deleting the first word "Applications" and inserting in place thereof the words "Consistent with section 12.18.020, applications."

SECTION 6. Title 13, Chapter 13.08, Section 13.08.365 of the Revised Ordinances of the city of Revere is hereby amended by deleting the words "sewer layer" throughout and inserting in place thereof the words "drain layer."

SECTION 7. Title 13, Chapter 13.08, Section 13.08.365 of the Revised Ordinances of the city of Revere is hereby amended by deleting the words "superintendent of public works" and inserting in place thereof the words "director of public works and/or the city engineer."

To Whom It May Concern:

We, the undersigned members of the Revere City Council, write to you today to formally request that a representative from Roseland Residential/Veris Residential appear before our Council to give an update on the Master Plan, dated November 6, 2019, and specifically, to ask that your property management company prioritize transportation improvement projects previously discussed to help mitigate the traffic on Salem Street, North Revere. This is a second request for an update, as the City Council on February 7, 2022 informally asked through a motion of the Ward Six Councillor that the property management company of Overlook Ridge provide the City of Revere with an update regarding the eventual reconfiguration of the entrance to Overlook Ridge and access to Route 1.

In conjunction with the Master Plan presented to the City of Revere in 2019, Roseland Residential suggested that the following transportation improvements were in the works (at cost to the property management company), given the significant impacts to local traffic on the North Revere neighborhood as a direct result of the Overlook Ridge apartment buildings:

- The elimination of the existing Lynn Street on-/off-ramps from Route 1 northbound to Lynn Street;
- Construction of a new on-/off-ramp system to Overlook Ridge Drive that provides a safer connection than the current Lynn Street ramps;
- Reconstruction/realignment of portions of the existing Overlook Ridge Drive to support Route 1 access and to completed related roadway improvements;
- Installation of a fully signalized intersection (with pedestrian safety improvements) at a relocated intersection of Overlook Ridge Drive and Salem Street;
- Reconstruction/realignment of Salem Street in front of Overlook Ridge site; and
- Installation of new MBTA bus stops/shelters on Salem Street to support the public transportation needs and to allow for buses and local traffic to operate more efficiently and safely.

As traffic returns to pre-pandemic levels combined with the fact that more residential apartment buildings on the Malden side of the property have been constructed over these last two years, the time is now for Roseland/Veris to step-up to make good on these commitments to transportation improvements for the neighborhood. The residents of North Revere who live on Salem Street and on the abutting streets have seen a significant increase in traffic as Overlook Ridge has been built-out, yet they have received little tangible mitigation for this encroachment on their quality of life.

The traffic improvements described in your 2019 Master Plan are not only palatable, but are sorely needed today – not in two years from now or five years from now, but as soon as possible. There is a constant flow of vehicles entering and exiting Overlook Ridge Drive at any given time, and during the morning and evening rush hours, many North Revere residents traversing Salem Street report being cut off by erratic drivers from Overlook Ridge as tenants seek to enter or exit the property in a rush to get to and from the Route 1 ramps.

We strongly encourage you to collaborate with the appropriate officials at MassDOT and the Cities of Revere and Malden to move swiftly on access to Route 1 through the Overlook Ridge property, as well as constructing the signalized intersection at Overlook Ridge Drive and Salem Street. Both of these enhancements will have a tremendously positive impact on traffic flow on Salem Street, and will help to improve the quality of life for our residents who live in North Revere. We look forward to your response. Thank you.
