### **Zoning Sub-Committee Report**

The Zoning Sub-Committee met on Monday, April 8, 2024 at 5:00PM in the City Councillor Joseph A. DelGrosso City Council Chamber, Revere City Hall, 281 Broadway, Revere, MA 02151. Committee members present were Councillors Guarino-Sawaya, Kelley, Novoselsky, Silvestri, and Chairman Zambuto.

24-022 An Ordinance Further Amending the Revised Zoning Ordinances of the City of Revere Relative to Home-Based Childcare.

Councillors McKenna and Silvestri offered the following minor technical amendments to the proposed ordinance.

- 1. See Section 4 Section 17.08.150 is amended by Inserting "(EEC)" after the words "Massachusetts Department of Early Education and Care".
- 2. See Section 5 Section 17.08.151 is amended by deleting "more than ten children" and inserting in place thereof "the number of children allowed by EEC".
- 3. See Section 6 Section 17.08.152 is amended by deleting "ten" and inserting in place thereof "the maximum number of children allowed by EEC".
- 4. See Section 7 Section 17.08.275 is amended by deleting "the Massachusetts Department of Early Childhood Education and Care" and inserting in place thereof "EEC".
- 5. See Section 7 Section 17.08.275 is hereby amended by deleting "6" and inserting in place thereof "the number of children allowed by EEC".
- 6. See Section 8 Section 17.08.276 is amended by deleting "the Massachusetts Department of Early Childhood Education and Care" and inserting in place thereof "EEC".
- 7. See Section 8 Section 17.08.276 is amended by deleting "10" and inserting in place thereof "the total number of children allowed by EEC for a large family child care home".
- 8. See Section 8 Section 17.08.276 is amended by deleting the second to last sentence in

its entirety and inserting in place thereof, "A large family child care home shall employ the minimum number of approved assistants required by EEC when the total number of children participating in child care meets the EEC requirement for employment of assistant(s)."

- 9. See Section 16 Section 17.44.020(D) is amended by deleting "six (6) children at a time" and inserting "the total number of children allowed by EEC at a time".
- 10. See Section 16 Section 17.44.020(E) is amended by deleting "ten (10) children at a time" and inserting "the total number of children allowed for large family child care homes by EEC at a time".

The committee unanimously approved the amendments as provided.

The proposed ordinance, as amended, is now before the committee.

The committee unanimously voted to offer a favorable recommendation for adoption of the proposed ordinance, as amended.

Overlook Ridge, LLC c/o Veris Residential, Harborside 3, 210 Hudson Street, Jersey City, NJ 07311, relative to A Zoning Ordinance Further Amending the Overlook Ridge Overlay District.

Councillor Silvestri offered the following amendment to the proposed ordinance:

Section 17.23.080 is hereby amended by inserting new subsection as follows:

Section 17.23.080(F) General regulations for the OROD

F. The owner(s) of the property shall provide the City of Revere with a development agreement that stipulates a flag pole must be maintained on Lot 1 at a location to be approved by the Site Plan Review Committee, and further that the development agreement stipulates that 15% of the proposed residential units to be constructed on Lot 15 located in the City of Revere be reserved for affordable housing with at least five (5) of those units reserved for affordable veterans housing.

Chief of Planning & Economic Development Tom Skwierawski indicated that due to the Fair Housing Act, the City Council cannot specify who the affordable units can be reserved for (i.e. seniors, veterans, etc.)

The committee entertained striking the words, "with at least five (5) of those units reserved for affordable veterans housing." and ending the sentence after the first instance of the word housing.

The committee unanimously approved the proposed amendment as discussed.

The proposed ordinance, as amended, is now before the committee.

The committee unanimously voted to offer a favorable recommendation for adoption of the proposed ordinance, as amended.

24-115 Amendment to the Zoning Map of the City of Revere relative to the CD and RA1 Zoning Districts in North Revere.

Frank Stringi, City Planner addressed the committee on his request.

The proposed ordinance is now before the committee.

The committee unanimously voted to offer a favorable recommendation for adoption of the zoning map amendments as offered by the City Planner.

8 Revere Street, LLC, 8 Revere Street, Revere, MA 02151 requesting a special permit from the Revere City Council to raze the existing non-confirming structure and construct a nine (9) unit townhouse development at 8 Revere Street, Revere, MA 02151.

Site Plan Review provided several conditions for the City Council to consider incorporating into the special permit:

- 1. The developer shall plant 14 pine trees (minimum 8-ft tall) along the back property line every 10 feet on center, 6 trees (minimum caliper of 2 1/2") along the back of sidewalk along the Revere Street frontage of the site, and shall plant a tree (minimum caliper of 2 1/2") in front of each unit for a total of 9 trees along the interior driveway.
- 2. The demolition and remediation of the existing structure shall be completed prior to any site work on the property.
- 3. A sewer connection and water connection permit must be obtained from the DPW for all new construction. The City Engineer and DPW Superintendent must review and approve the proposed sewer service and water service plan as well as storm water management plan and erosion control plan.
- 4. The plans must be reviewed and approved by the Fire Dept.
- 5. Hydrant flow tests shall be conducted to determine the adequacy of both domestic and fire flow and for the proper sizing of domestic and fire flow service lines to the proposed project. Plans for the location of additional hydrants shall be approved by the Revere Fire Dept.
- 6. Concrete sidewalks with granite curbing shall be installed along the full frontage of the property along Revere Street.
- 7. All existing water and sewer lines within the site shall be abandoned and shall be capped at the main and removed.
- 8. The building design and materials plan as well as the landscaping and streetscape plan shall be approved by the Site Plan Review Committee. These plans shall be filed as part of the building permit application.
- 9. The site lighting scheme shall be subject to the approval of the Site Plan Review Committee and all lights within the parking areas that may impact abutting residential properties shall provide screens/deflectors and or soft or directional lighting to minimize light being reflected on abutting residential properties.
- 10. The final grading of the lot shall be such that no runoff is diverted to abutting properties.
- 11. Irrigation systems shall be installed for all landscaped areas within the project site.

The special permit, subject to the conditions of Site Plan Review, received a favorable recommendation for the City Council to grant the relief requested.

# A ZONING ORDINANCE FURTHER AMENDING TITLE 17 RELATIVE TO FAMILY HOME-BASED CHILD CARE REGULATIONS

*Be it ordained by the City of Revere as follows:* 

**SECTION 1.** Title 17, Chapter 17.08, Section 17.08.150 Cellar of the Revised Ordinances of the City of Revere is hereby amended by deleting this section in its entirety.

**SECTION 2.** Title 17, Chapter 17.08 Definitions of the Revised Ordinances of the City of Revere is hereby amended by inserting a new definition as follows:

17.08.146 - Cellar

"Cellar" means a story, partly or entirely underground, having more than one-half of its clear height below the average level of the finished outside grade of the lot.

**SECTION 3.** Title 17, Chapter 17.08, Section 17.08.195 Day Nursery of the Revised Ordinances of the City of Revere is hereby amended by deleting this section in its entirety.

**SECTION 4.** Title 17, Chapter 17.08 Definitions of the Revised Ordinances of the City of Revere is hereby amended by inserting the following new definition: 17.08.150 - Child care center.

"Child care center" means any facility operated on a regular basis by an entity licensed by the Massachusetts Department of Early Education and Care (EEC) under M.G.L c. 15D, § 1A, which may be known as a child nursery, nursery school, kindergarten, child play school, progressive school, child development center, or preschool, or known under any other name, which receives children not of common parentage under 7 years of age, or under 16 years of age if those children have special needs, for nonresidential custody and care during part or all of the day separate from their parents.

Child care center shall not include: any part of a public school system; any part of a private, organized educational system, unless the services of that system are primarily limited to kindergarten, nursery or related preschool services; a Sunday school conducted by a religious institution; a facility operated by a religious organization in which children are cared for during short periods of time while persons responsible for the children are attending religious services; a family child care home; an informal cooperative arrangement among neighbors or relatives; or the occasional care of children with or without compensation.

**SECTION 5.** Title 17, Chapter 17.08 Definitions of the Revised Ordinances of the City of Revere is hereby amended by inserting the following new definition:

17.08.151- Child care center, Large Group and School Age Child Care

"Large Group and School Age Child Care" means any program that receives on a regular basis the number of children allowed by EEC who are unrelated to their caregivers and are younger than 14 years old, or 16 years, if such children have special needs, during all or part of the day for non-residential care and education outside their own homes. Such programs shall include, but not be limited to, those commonly known as child care centers, day care centers, preschools, nursery schools, child development programs, school age child care programs and before and after school programs, regardless of their location. Such programs shall not include any part of a public school system; any part of a private organized educational system, unless the services of such a system are primarily limited to kindergarten, nursery or related pre-school services; any part of a program operated by an organized educational system for the children enrolled in that particular system, unless the services of such system are primarily limited to a school age child care program; Sunday schools or classes for religious instruction conducted by a religious institution; a facility operated by a religious organization where children are cared for during short periods of time while persons responsible for such children are attending religious services; an informal cooperative arrangement among neighbors or relatives; or the occasional care of children with or without compensation therefore.

**SECTION 6.** Title 17, Chapter 17.08 Definitions of the Revised Ordinances of the City of Revere is hereby amended by inserting the following new definition:

17.08.152 - Child care center, Small Group and School Age Child Care

"Small Group and School Age Child Care" means any program that receives on a regular basis the maximum number of children allowed by EEC or fewer who are unrelated to their caregivers and are younger than 14 years old, or 16 years, if such children have special needs, during all or part of the day for non-residential care and education outside their own homes, when such services are not provided in a private residence. Such programs shall include, but not be limited to, those commonly known as child care centers, preschools, nursery schools, child development programs, school age child care programs and before and after school programs. Such programs shall not include any part of a public school system; any part of a private organized educational system, unless the services of such a system are primarily limited to kindergarten, nursery or related pre-school services; a Sunday school conducted by a religious institution; a facility operated by a religious organization where children are cared for during short periods of time while persons responsible for such children are attending religious services; a family child care home; an informal cooperative arrangement among neighbors or relatives; or the occasional care of children with or without compensation therefore.

**SECTION 7.** Title 17, Chapter 17.08, Section 17.08.275 Family child care home of the Revised Ordinances of the City of Revere is hereby amended deleting the definition in its entirety and inserting the following new definition.

17.08.275 - Family child care home.

"Family child care home" means any private residence which is licensed by EEC and which, on a regular basis, receives for temporary custody and care during part or all of the day, children under 7 years of age, or children under 16 years of age if those children have special needs, and receives for temporary custody and care for a limited number of hours children of school age under regulations adopted by the board. The total number of children under 16 in a family child care home shall not exceed the number of children allowed by EEC, including participating children

living in the residence. Family child care home shall not mean a private residence used for an informal cooperative arrangement among neighbors or relatives, or the occasional care of children with or without compensation.

**SECTION 8.** Title 17, Chapter 17.08 Definitions of the Revised Ordinances of the City of Revere is hereby amended by inserting the following new definition:

17.08.276 - Family child care home, Large

"Large family child care home" means any private residence which is licensed by EEC and which, on a regular basis, receives for temporary custody and care during part, or all of the day, children under 7 years of age, or children under 16 years of age if such children have special needs, and receives for temporary custody and care for a limited number of hours children of school age under regulations promulgated by the board, but the number of children under the age of 16 in a large family child care home shall not exceed the total number of children allowed by EEC for a large family child care home, including participating children living in the residence. A large family child care home shall employ the minimum number of approved assistants required by EEC when the total number of children participating in child care meets the EEC requirement for employment of assistant(s). Large family child care home shall not mean a private residence used for an informal cooperative arrangement among neighbors or relatives, or the occasional care of children with or without compensation.

**SECTION 9.** Title 17, Chapter 17.08 Definitions of the Revised Ordinances of the City of Revere is hereby amended by inserting the following new definition:

17.08.277 - Family child care system.

"Family child care system" means a person who, through contractual arrangement, provides to family child care homes, which have been approved as members of that system, central administrative functions including, but not limited to: training of operators of family child care homes; technical assistance and consultation to operators of family child care homes; inspection, supervision, monitoring and evaluation of family child care homes; referral of children to available family child care homes; and referral of children to available health and social services. Family child care system shall not mean a placement agency or a child care center.

**SECTION 10.** Title 17, Chapter 17.16, Section 17.16.040B Institutional Generally Table of Uses of the Revised Ordinances of the City of Revere is hereby amended by deleting day nursery, family day care home, and family day care home and inserting the following new uses within Section 17.16.040A Residential Generally Table of Uses:

**SECTION 11.** Title 17, Chapter 17.16, Section 17.16.080 of the revised ordinances of the City of Revere is hereby amended by removing this section in its entirety and inserting the following new section:

17.16.80 - Child Care Center.

A child care center may be allowed in the RA, RA1, RB, RB1, RC, RC1, RC2, RC3, NB, GB, GBI, HB, TED, CB, LI, IP, PDD1 and PDD2 districts in conformance with the following criteria:

- A. A child care center shall comply in all respects with the standards for licensure and approval in accordance with Regulation 102 CMF 7.00 of the Office for Children.
- B. A child care center located in a residential district shall have outdoor play areas which are fenced on all sides and include screening where such areas abut a residential use. Minimum screening for outdoor play areas which abut a residential use shall include an appropriate landscaping screen and/or stockade fencing.
- C. A child care center located in commercial or industrial districts which have outdoor play areas, shall provide fencing and screening on all sides. Screening areas shall include a five foot landscaped buffer zone where such play areas abut a commercial or industrial district or use.
- D. If the child care center is located within a residential district, there shall be no parking allowed within the front yard. If the day nursery is located in a residential structure and/or district, the facility must provide one off-street parking space per two hundred gross square feet of nursery space in addition to the residential requirements.
- E. If the child care center is located in a commercial structure and/or district, the facility will be required to provide one off-street parking space per two hundred gross square feet of nursery space in addition to the commercial parking requirements.
- F. Swimming pools are prohibited on the premises of a child care center.

**SECTION 12.** Title 17, Chapter 17.16, Section 17.16.085 Family day care home of the Revised Ordinances of the City of Revere is hereby amended deleting this section in its entirety and inserting in place thereof the following new use regulation:

17.16.85 - Family child care home.

A family child care home may be allowed in the RA, RA1, RB, RB1, RC, RC1, RC2, RC3, NB, GB, GB1, CB, PDD1 and PDD2 districts in conformance with the following minimum criteria:

- A. Separation between family child care homes. Within a residential district, no other large family child care home shall be located and operating within the same building of an existing large family child-care home or child care center.
- B. Swimming pools are prohibited on the premises of a family child care home.

**SECTION 13.** Title 17, Chapter 17.26, Section 17.26.040(T) Allowed Uses in the Suffolk Downs Overlay District of the Revised Ordinances of the City of Revere is hereby amended by deleting this subsection and inserting in place thereof the following new subsection.

**April 8, 2024** 

T. Religious facility; public or private lodge or club; child care center or elderly care center; family child care home; nursing or convalescent home; public, private or nonprofit school; community or adult education center; and other similar uses and facilities.

- **Section 1.** Section 12.04.080(A)(1) of the Revised Ordinances of the City of Revere is hereby amended by removing the words "two hundred" and inserting in place thereof the words "five-hundred."
- **Section 2.** Section 12.04.080(A)(1) of the Revised Ordinances of the City of Revere is hereby amended by removing the period after the word "required" and inserting in place thereof the words "for a street or sidewalk opening permit."
- **Section 3.** Section 12.04.080(A)(3) of the Revised Ordinances of the City of Revere is hereby amended by removing the words "five thousand" and inserting in place thereof the words "ten-thousand."
- **Section 4.** Section 12.04.080(A)(5) of the Revised Ordinances of the City of Revere is hereby amended by deleting this subsection in its entirety and inserting in place thereof the following the new subsection:
  - 5. The superintendent of public works shall not issue any street or sidewalk opening permits to any permittee or excavator within five years of the final approval of any newly paved street or sidewalk by the superintendent of public works and the city planner unless in the case of an emergency, including but not limited to a gas leak, water break, water leak, sewer break, or sewer blockage. New installations for gas, water lines, sewer lines or connections shall not be permitted during the aforementioned moratorium.
- **Section 5.** Section 12.04.080(C)(9)(c) of the Revised Ordinances of the City of Revere is hereby amended by removing the word "crackfilling" and inserting in place thereof the words "crack filling."
- **Section 6.** Section 12.04.080(C)(10) of the Revised Ordinances of the City of Revere is hereby amended by removing the word "three" from the first sentence and inserting in place thereof the word "four."
- **Section 7.** Section 12.04.080(D) of the Revised Ordinances of the City of Revere is hereby amended by re-lettering this subsection to "E. Billing and Collections."
- **Section 8.** Section 12.04.080 of the Revised Ordinances of the City of Revere is hereby amended by inserting the following new subsection "D. Winter Excavations";
  - D. Winter Excavations

- 1. Excavations into paved areas between November 15<sup>th</sup> through April 15<sup>th</sup> are authorized by the City of Revere in accordance with the department of public works' "Rules and Specifications for Winter Excavation Activity within the City of Revere." These rules and specifications shall be available to the public on the City of Revere's website and at the Department of Public Works' offices.
- 2. Approvals for permit requests for work occurring after November 15<sup>th</sup> shall be conditional upon adherence to the "Rules and Specifications for Winter Excavation Activity Within the City of Revere." A street or sidewalk opening permit shall be issued upon receipt of a signed acknowledgement of the aforementioned rules and specifications by the permittee. Failure to adhere to the rules and specifications may result in the cancellation and refusal of existing and future permits. In addition to the requirements of 12.04.080(A), an additional Winter Excavation Fee of five-hundred dollars (\$500.00) is required upon approval of the permit. This fee is to offset the cost to the City of excavation issues pertaining to work being completed in winter months.
- 3. Water main shutdowns during winter months will be allowed solely at the discretion of the Revere Water Department.
- 4. This subsection shall take effect November 14, 2024.
- **Section 9.** Section 12.04.080(E) of the Revised Ordinances of the City of Revere is hereby amended by re-lettering this subsection to "F. Administration/Interpretation."

# An Act Relative to City Employment and Candidacy in the Offices of Mayor, City Councillor-at-Large, Ward Councillor, and School Committee of the City of Revere

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

#### **PREAMBLE**

- WHEREAS, the City of Revere recognizes that separation of powers is a model that divides government into separate branches, each of which has separate and independent powers. Separation of powers is associated with the checks and balances system in the United States of America; and
- WHEREAS, the checks and balances system provides each branch of government with individual powers to check the other branches and prevent any one branch from becoming too powerful; and
- WHEREAS, the City of Revere recognizes that there must be a limitation on the power of government to ensure its residents' right to liberty and protection from tyranny; and
- WHEREAS, the City of Revere recognizes that elected officials are morally obligated to serve the public free from conflicts of interest; and
- WHEREAS, special legislation is necessary to allow the City of Revere to prevent egregious conflicts of interest arising from a lack of separation of powers which devalues the trust and confidence that the voters place in its elected officials.
- <u>Section 1.</u> No city councillor or member of the school committee shall hold any appointive city office or city employment during their term and until two years following the expiration of the term for which they were elected. This provision shall not prohibit a city officer or city employee who has taken a leave of absence from such office or employment from resuming their duties as such following service as a city councillor.
- **Section 2.** Candidates for the office of mayor, office of city councillor-at-large, office of ward councillor, or school committee, who serve in any appointive city office or city employment, shall take a leave of absence from their employment. City officers or employees shall be considered a candidate for office when nomination papers have been submitted and certified in accordance with all applicable election laws of the Commonwealth of Massachusetts. This provision shall not prohibit a city officer or city employee from resuming their duties pending the outcome of the regular municipal election or if applicable, the outcome of the preliminary election.
- <u>Section 3.</u> No person shall be a candidate for more than one municipal office at the same election.
- **Section 4.** This act shall take effect upon its passage.

  - c. The interpretation shall be triggered if at least 10% of the city's population speaks the said language.
- ii. All city departments shall provide interpreted documents such as a public notifications or pamphlets in at least one language other than English.
  - a. All public notifications shall be interpreted from English to at least one language other than English.
  - b. The language other than English shall be determined by the data from the latest Federal Census and serve the next most spoken language other than English in the city first.
  - c. The interpretation shall be triggered if at least 10% of the city's population speaks the said language.
- iii. The City shall arrange for professional interpretation services to be available at all public meetings. Translation services shall include, not limited to, simultaneous interpretation during the meeting.
- iv. The City shall develop and implement a plan outlining procedures for interpretation services. The plan shall be made publicly available on the City's official website.
- v. The City shall engage qualified and certified interpreters for said language interpretation services. Interpreters should possess linguistic and cultural proficiency and familiarity with local government terminology.
- vi. The City shall provide notice to the public about the availability of interpretation services at public meetings through various channels, including the official website, public announcements, and printed materials. Notice shall include information on how to request specific language assistance.

- vii. Funding for interpretation services shall be allocated in the City's annual budget, and necessary resources shall be provided to ensure the effective implementation of this ordinance.
- viii. This ordinance shall take effect on July 1, 2024.

# AN ORDINANCE PROVIDING FOR INTEPRETATION AND TRANSLATION SERVICES FOR PUBLIC MEETINGS AND PUBLIC DOCUMENTS:

Be it ordained by the City of Revere as follows:

Section 1. Section 2.03.050 of the Revised Ordinances of the City of Revere is hereby amended by inserting the following new sub-section:

F. Interpretation Services for Public Meetings.

#### 1. Definitions

- a. "Interpretation" or "interpretation services" shall mean the act of a qualified interpreter communicating live conversation from the source language into the target language.
- b. "Public body," pursuant to M.G.L. c. 30A §§ 18-25, shall mean a multiple-member board, commission, committee or subcommittee within the executive or legislative branch or within any county, district, city, region or town, however created, elected, appointed or otherwise constituted, established to serve a public purpose; provided, however, that the governing board of a local housing, redevelopment or other similar authority shall be deemed a local public body; provided, further, that the governing board or body of any other authority established by the general court to serve a public purpose in the commonwealth or any part thereof shall be deemed a state public body; provided, further, that "public body" shall not include the general court or the committees or recess commissions thereof, bodies of the judicial branch or bodies appointed by a constitutional officer solely for the purpose of advising a constitutional officer and shall not include the board of bank incorporation or the policyholders protective board; and provided further, that a subcommittee shall include any multiple-member body created to advise or make recommendations to a public body.
- c. "Public meeting," pursuant to M.G.L. c. 30A §§ 18-25, shall mean a deliberation by a public body with respect to any matter within the body's jurisdiction, provided, however, "meeting" shall not include:
  - i. an on-site inspection of a project or program, so long as the members do not deliberate;
  - ii. attendance by a quorum of a public body at a public or private gathering, including a conference or training program or a media, social or other event, so long as the members do not deliberate;

iii. attendance by a quorum of a public body at a meeting of another public body that has complied with the notice requirements of the open meeting law, so long as the visiting members communicate only by open participation in the meeting on those matters under discussion by the host body and do not deliberate;

iv. a meeting of a quasi-judicial board or commission held for the sole purpose of making a decision required in an adjudicatory proceeding brought before it; or

v. a session of a town meeting convened under section 9 of chapter 39 which would include the attendance by a quorum of a public body at any such session.

- d. "Public notification" shall mean any document disseminated by a city department for public consumption.
- e. "Translation" or "translation services" shall mean the act of a qualified translator converting written content from the source language into the target language.
- 2. The purpose of this section is to ensure inclusivity and accessibility by providing language interpretation and translation services for meetings of public bodies meetings and documents. Said interpretation and translation services must shall meet the following requirements:
  - a. Public meetings shall be interpreted from English to at least one language other than English.
  - b. The language other than English shall be determine by the data from the latest Federal Census and serve the next most spoken language other than English in the city first.
  - e.<u>b.</u> The use of interpretation shall be triggered if at least 10% of the city's population speaks the said language <u>according to the US Census'</u>
    <u>American Community Survey 5</u>-
- 3. All city departments shall provide interpreted translated documents including but not limited to such as public notifications or informational pamphlets in a language other than English.
  - a. All public notifications shall be interpreted translated from English to at least one language other than English.
  - b. The language other than English shall be determine by the data from the latest Federal Census and serve the next most spoken language other than English in the city first.

- eb. The use of interpretation translation shall be triggered if at least 10% of the city's population speaks the said language according to the US Census' American Community Survey.
- 4. The City shall arrange for professional interpretation services to be available at all public meetings in accordance with the provisions set out by sub-section 2.03.050(2). Translation Interpretation services shall include but are not limited to simultaneous interpretation during the meeting. The City shall require reasonable qualifications, including but not limited to certification from interpreters.
- 5. The City shall develop and implement a plan, <u>called the Language Access Plan</u>, outlining procedures for interpretation and translation services. The plan shall be made publicly available on the City's official website.
- 6. The City shall engage qualified and certified interpreters for said language interpretation services. Interpreters should possess linguistic and cultural proficiency and familiarity with local government terminology.
- 6. The City shall provide notice to the public notice about of the availability of interpretation services at public meetings through various channels, including but not limited to the official City website, public announcements, and printed materials. Notice shall include information on how to request specific language assistance.
- 7. Funding for interpretation and translation services shall be allocated in the City's annual budget, and necessary resources shall be provided to ensure the effective implementation of this ordinance.
- 8. This ordinance shall take effect on July 1, 2024.

Dear Honorable Council Members.

I am writing to commend the Revere City Council's commitment to inclusivity, particularly the recent proposal for an ordinance providing interpretation services for all public meetings and translation for all city documents.

While the intention is admirable, I would like to offer some considerations to enhance the comprehensiveness of the proposed approach for council order 24-061 "An ordinance providing interpretation services for public meetings and public documents."

Firstly, it's crucial to acknowledge the potential challenges associated with the ordinance, especially considering the lofty price tag that interpretation services "for all live meetings" might entail. The City has already demonstrated its dedication to linguistic inclusivity through the provision of city translation devices for meetings upon request and in-person interpretation services at city hall.

While the ordinance aims to enhance inclusivity, here are my concerns how this ordinance might not be fully inclusive:

Language Limitations: The ordinance focuses on the second most spoken language based on census data. This may overlook smaller linguistic communities, potentially leaving them without adequate interpretation services, thereby excluding them.

**Dynamic Language Shifts:** Relying solely on census data might not capture dynamic language shifts within the community. Emerging language needs may be overlooked, leading to potential exclusion.

**Accessibility Barriers**: Despite offering interpretation services, individuals who speak languages beyond the prioritized one may still face accessibility barriers, hindering their full participation in public meetings and understanding of documents.

**Cultural Competence**: While interpreters are required to possess linguistic proficiency, cultural competence is equally vital. Failure to consider this aspect may result in a lack of understanding of diverse cultural nuances, potentially excluding certain communities.

**Communication Gaps:** Public awareness efforts may not reach all residents, leading to communication gaps. Some individuals might not be aware of the available interpretation services, making the city's communication less inclusive.

**Exclusion of Non-English Speakers:** The ordinance primarily addresses non-English speakers. However, it might not fully encompass individuals who are proficient in English but may still face barriers due to legal or technical language complexities in public documents.

**Potential Stigmatization**: Prioritizing specific languages based on demographic data might unintentionally stigmatize smaller linguistic communities, making them feel less valued or recognized by the city.

With a significant portion of the 10% category, the city has demonstrated resource efficiency in addressing the linguistic needs of a substantial part of its population. The existing translation efforts by the city have been effective in meeting the language needs of the community, reducing the necessity for additional interpretation services. Instead of expanding Interpretation services, resources could be redistributed to address other pressing needs withing the community or to enhance existing services.

To optimize resources and ensure a more adaptive and inclusive framework, I propose the following:

**Community Engagement:** Actively engage with the community to identify language preferences and ensure that interpretation services align with the evolving linguistic landscape. (For instance, there are 33 different languages spoken at the homes of Revere Public School Students).

**Tailored Solutions**: Customize language support based on community feedback and specific requirements, acknowledging that a one-size-fits-all approach may not cater to the unique linguistic needs of diverse communities.

**Continuous Evaluation**: Establish a system for continuous evaluation and adaptation of language services based on community feedback and demographic changes.

**Multifaceted Outreach**: Expand public awareness efforts to reach all corners of the community through collaboration with community organizations, local media, and educational institutions.

**Legal Accessibility:** Ensure that legal documents are not only translated but also presented in a comprehensible manner, addressing potential barriers posed by legal jargon.

It's important to note that the city's existing provision of translation devices and in-person interpretation services at City Hall is commendable. Building upon these initiatives and incorporating the proposed considerations will contribute to a more holistic and effective approach to linguistic inclusivity.

I believe that the proposed enhancements can be implemented within existing resources, ensuring a balance between inclusivity and fiscal responsibility without needing a city ordinance in place.

Thank you for your dedication to creating an inclusive community, and I appreciate your consideration of these suggestions. I look forward to witnessing the continued progress towards a more linguistically diverse and accessible city.

As part of the FY2025 budget process, the City Council ordained departmental revolving funds as they relate to Massachusetts General Law Chapter 44, Section 53 E ½. The Massachusetts Modernization Act (the Act) allowed for cities and towns to create an ordinance for departmental revolving funds to avoid the annual vote of creating these funds. However, the Act still requires the legislative body to set the maximum amount annually to be expended on or before July 1 for the upcoming fiscal year.

As such, please find attached a list of all departmental revolving funds adopted by the Council with a maximum allowable expenditure amount for each. Also, please find attached a copy of the law for departmental funds for your convenience.

I respectfully request that the Council adopt the attached schedule to set the maximum allowable expenditures for the City's departmental revolving funds.

#### Section 53E1/2: Revolving funds

Section 53E1/2. Notwithstanding section 53, a city or town may authorize by by-law or ordinance the use of 1 or more revolving funds by 1 or more municipal agencies, boards, departments or offices, which shall be accounted for separately from all other monies in the city or town and to which shall be credited any fees, charges or other receipts from the departmental programs or activities supported by the revolving fund. Expenditures may be made from such revolving fund without further appropriation, subject to the provisions of this section; provided, however, that expenditures shall not be made or liabilities incurred from any such revolving fund in excess of the balance of the fund or in excess of the total authorized expenditures from such fund, and no expenditures shall be made unless approved in accordance with sections 41, 42, 52 and 56 of chapter 41.

Interest earned on any revolving fund balance shall be treated as general fund revenue of the city or town. No revolving fund may be established under this section for receipts of a municipal water or sewer department, a municipal hospital, a cable television access service or facility or for receipts reserved by law or as authorized by law for expenditure for a particular purpose. Revolving fund expenditures shall not be made to pay wages or salaries for full-time employees unless the revolving fund is also charged for the costs of fringe benefits associated with the wages or salaries so paid; provided, however, that such prohibition shall not apply to wages or salaries paid to full-time or part-time employees who are employed as drivers providing transportation for public school students; provided further, that only that portion of a revolving fund which is attributable to transportation fees may be used to pay the wages or salaries of those employees who are employed as drivers providing transportation for public school students; and provided further, that any such wages or salaries so paid shall be reported in the budget submitted for the next fiscal year.

A revolving fund shall be established pursuant to this section by by-law or ordinance. The by-law or ordinance shall specify for each fund: (1) the programs or activities for which the revolving fund may be expended; (2) the departmental receipts in connection with those programs or activities that shall be credited to the revolving fund; (3) the board, department or officer authorized to expend from such fund; and (4) any reporting or other requirements the city or town may impose. The establishment of any fund shall be made not later than the beginning of the fiscal year in which the fund shall begin. Notwithstanding this section, whenever, during any fiscal year, any new revenue source becomes available for the establishment of a revolving fund under this section, such a fund may be established in accordance with this section upon certification by the city auditor, town accountant, or other officer having similar duties that the revenue source was not used in computing the most recent tax levy.

The city or town shall, on or before July 1 of each year, vote on the limit on the total amount that may be expended from each revolving fund established under this section. In any fiscal year, the limit on the amount that may be spent from a revolving fund may be increased with the approval of the city council and mayor in a city or with the approval of the board of selectmen and finance committee in a town.

Upon termination of a revolving fund, the balance in the fund at the end of that fiscal year shall revert to surplus revenue at the close of the fiscal year.

The director of accounts may issue guidelines further regulating revolving funds established pursuant to this section.

RE: WinWaste - Contract Renewal

Dear Council President Cogliandro,

The current contract between the city and WinWaste expires at the end of the calendar year. The current contract ran from January 1, 2015 through June 30, 2024. We have been in negotiations with WinWaste over the past several months with the goal of entering another ten (10) year contract.

As such, please find below the contract that the city and WinWaste have agreed to in terms, subject to Council approval. This contract has fixed rates for five (5) years (FY25-29) with mutual option extensions from FY30-34.

In summary, the initial increase for FY2025 is 5.7% (currently @ \$83.51), and FY26-29 is 4%, as follows:

- FY25 ~ \$88.25
- FY26 ~ \$91.78
- FY27 ~ \$95.45
- FY28 ~ \$99.27
- FY29 ~ \$103.24

This proposal also has options for years six and seven @ 4.25% increase or CPI, whichever is greater and years eight, nine and ten at 4.5% increase or CPI, whichever is greater.

Further, we will be able to dump our yard waste for free, so long as the Saugus Monofil remains open and operating. The current rate is \$17.00 per ton. Finally, WinWaste will donate \$25,000 annually to the City to be used at the City's discretion.

This proposal includes free yard waste disposal at the Saugus Monofil. This is contingent on the Monofil remaining open and operating. If the Monofil closes, we will not be able to accept yard waste at the facility and the city will need to seek alternative yard waste disposal.
