14-100 Motion presented by Councillor Novoselsky: That Mayor request the Traffic Commission to conduct a public hearing to amend Schedule IV of Title 10 Isolated Stop Signs to provide for a "Stop" sign at the intersection of Shirley Ave. and Walnut Ave. for eastbound traffic.

14-101 Motion presented by Councillor Haas: That the City Council issue Certificates of Commendation to the officers involved with “Operation High Tide” leading to the arrest of twenty-six drug dealers.

14-108 Motion presented by Councillor Haas: That the following Special Legislation be forwarded to the State Delegation for approval:

An Act Amending Chapter 134 of the Acts of 2004 Authorizing the City of Revere To Reduce Water and Sewer Fee Liability In Exchange For Volunteer Services By Persons Over Age 60.

Section 1. Chapter 134, Section 1(a), of the Acts of 2004 is hereby amended by deleting the words, "No such person shall receive a rate of, or be credited with, more than the current minimum wage of the commonwealth per hour for services provided pursuant to such reduction, nor shall the reduction of the water and sewer bill exceed \$500 in a tax year." and inserting in place thereof, "The reduction of the water and sewer bill shall not exceed \$750 in a tax year."
