4. Municipal Parking Lot changes:

<u>Section 1.</u> Table 1 Fee Schedule, Business Parking Permit is hereby amended by reducing the fee from three hundred dollars to one hundred dollars.

Section 2. Table 1 Fee Schedule, Parking Meter Fees is hereby amended by deleting the last sentence and inserting in place thereof, "The fee for parking in a municipal off-street parking area on Shirley Avenue shall be twenty-five cents for each fifteen-minute interval. The fee for parking in a municipal off-street parking area on Central Avenue shall be fifty cents for each hour. The fee for parking in a municipal off-street parking area on Aucella Court shall be fifty cents for each hour.

<u>Section 3.</u> Section 10.36.060 Fees – Hours of Operation is hereby amended by inserting a new Sub-Section C as follows: "C. Meters at Aucella Court are utilized from nine a.m. to five p.m. Monday-Friday."
