#### **Business Restrictions**

- Customer limits, protective barriers, social distancing, prohibiting self-serve
- PPE (e.g., masks and gloves)

#### PREPARING YOUR FACILITIES

- Sanitize/disinfect
- Paint/refresh
- Hand sanitizing stations
- Signage
- Lower Occupancy
- Purchasing PPE
- FDA Checklist for Re-opening/self-inspection
- Disposable menus

#### **INSPECTIONS**

- FDA Checklist for Re-opening/self-inspection
- City inspections
- If your business has been closed for the entire time, you will need an inspection to reopen

#### **ENFORCEMENT**

- Follow State and Local guidelines
- Rules often fall through the cracks when the owner is not on site

#### As a business owner, can I apply for unemployment? Should I?

- You can apply for PUA, but you may want to apply for other resources instead like PPP.
  - Fill out a very simple intake form to consult with a lawyer for free about what makes the most sense for you: <a href="https://www.covidreliefcoalition.com/en/Forms/Intake-Form-for-Small-Businesses">https://www.covidreliefcoalition.com/en/Forms/Intake-Form-for-Small-Businesses</a>
- If you do apply for unemployment, make sure to...
  - Select "I am self employed, an independent contractor, or a gig worker and COVID-19 has severely limited my ability to perform my normal work" for "How has COVID-19 impacted your work?"
  - Calculate your total income from 2019 before starting the application. This is NOT the business's total income, it's your personal take-home pay.

#### **Supporting your Employees**

- Most important thing you can do is provide employees with basic information and respond to all requests from DUA promptly:
  - Employer Legal Name, Address and FEIN
  - Claimant Wage Request
- Workshare Program Reduction in all employee hours instead of layoffs.
  - https://www.mass.gov/workshare-for-employers
- Encourage them to look into other financial resources, like SNAP.

#### **General Tips**

- After a claim is accepted, you must request benefits on a weekly basis
- You do not need to do anything else to receive the additional \$600/wk from the federal government.
