- 3. Public Hearing DEP File No. 061-0708, 1064 North Shore Road, Renovation and Conversion of Commercial Building to Twelve (12) Apartments, Tripoli LLC, Jamie Russo. Motion to open the Public Hearing by Member Nicholas Moulaison, 2nd by Member Joseph LaValle. Voted in the affirmative unanimously. Peter Blaisdell presented on behalf of the applicate. Storm water and finished floor elevation were discussed.
