Revere Conservation Commission Minutes April 5, 2017 Revere City Hall 281 Broadway Revere, MA 02151

1. Roll Call – 7:00 PM – Member Vincent Lauria, Member Joseph LaValle, , , Member Nicholas Moulaison, Member Ann Raponi and Chairman Andrew B. DeSantis present, Member James Cerbone absent.

2. Minutes of March 1, 2017 – Motion to approve by Member Nicholas Moulaison, 2^{nd} by Member Vincent Lauria. Voted in the affirmative unanimously.

3. Motion to Open the Continued Public Hearing, Notice of Intent, DEP File No. 061-0684, Belcher Street – Lots 130, 129 part of Lot 128 Construction of Single Family Home – Cavallo Corporation by Member Ann Raponi, 2nd by Member Joseph A. LaValle, voted in the affirmative unanimously. Tony Esposito presented on behalf of the applicant. Motion to close the Public Hearing and issue an Order of Conditions by Member Nicholas Moulaison, 2nd by Member Ann Raponi. Voted in the affirmative unanimously.

4. Motion to Open the Public Hearing – Notice of Intent, DEP File No. 061-0692, 15 Arcadia, Demolition and installation of prefabricated single family home on reconstructed and expanded foundation, Hany Bandar by Member Nick Moulaison, 2nd by Member Ann Raponi, voted in the affirmative unanimously. Bill Manuel presented on behalf of the applicant. A neighbor Rod Burrow of 5 Arcadia Street asked about the supporting foundation for the proposed deck and spoke in favor of grant of the permit. Motion to close the Public Hearing and issue an Order of Conditions by Member Nicholas Moulaison, 2nd by Member Vincent Lauria. Voted in the affirmative unanimously.

Voted in the affirmative unanimously.
