Item #2: Presentation by Sarah Nechamen who is the Outreach and Training Specialist from DPCC (Disabled Persons Protection Commission). Independent State agency addressing abuse allegations on disabled persons aged 18-59/ DCF covers birth-17, EOEA (executive office of elder affairs) covers 60+/ Hotline number 1-800-426-9009, if intake meets criteria, case is assigned an investigator.... if + for abuse person gets added to the abuser registry, removed from current job. If someone reports suspected abuse, DPPC does not release name of the person reporting. Brochures with additional more comprehensive information is available and will be kept at the COD office.

Item #4: CODA (Commissions on Disabilities Alliance) – Monthly Zoom meeting May 4, 2022.

- Discussion by Cambridge COD regarding bike lanes and issues they are having and how they are being dealt with; HP spaces replaced as close to the proximity of previous spaces
- Discussions regarding State AAB (Architectural Access Board) Variance Applications.; where do applications go once received... COD and Building inspector

 Discussions regarding one of the Cities upcoming election and having accessible voting equipment and hesitation because of Covid fears. (simple resolution found); equipment will need to be wiped / disinfected between uses
