- **At the May monthly meeting it was discussed how a Pilot program offering live, on-site ASL interpreters at three mass vaccination sites: Hynes Convention Center, Gillette Stadium, and Natick Mall.**
- **Another new program which rolled out in May allowed organizations serving people with disabilities and other marginalized and hard-hit communities to request priority codes for appointments at 7 mass vaccination sites.**
- **At the June Meeting discussions were had regarding city and towns adopting Hybrid technology for all City Boards, Public hearings, and meetings.**
- **At the June Meeting it was also discussed that some of the MA State vaccination sites would be closing and shifting to local pharmacies.**
- **At the July meeting there were continued discussions regarding Public meeting and hearings having Hybrid accessibility. Also, the AG office has been having regular trainings on open meeting law and Hybrid meetings. CODA will also be reaching out to the AG office to see about having someone attend one of our Monthly meeting to have further discussions. Likewise, CODA is also reaching out to the ADA with the same request.**

- 1. SEPAC parent survey results: SEPAC sent parents of children on an IEP or 504 a survey in early June. The survey was shared in 4 languages.
