Item#1: The COD is Resubmitting An ADA Planning Grant for Fiscal year 2018. We did not receive the grant for fiscal year 2017 due to the funds not being available.

Item #2: Commission on Disabilities Office Update-After months of work, The Commission on Disabilities is ready to begin hosting in-person appointments. Starting on September 8, the Commission will work out of the American Legion Building/Veterans' Affairs office on Fridays from 8:15 AM to 12:15 PM. At this time, residents will be able to call or visit the Commission to discuss any ongoing issues. Co-Chair Ralph DeCicco will also be taking appointments in the Legion building at other times during the week by appointment only. Item #3: Update on Pedestrian Infrastructure Work-

- With School approaching, Mayor Arrigo and the City are working on pedestrian upgrades around the Paul Revere School and Garfield School that will improve accessibility for pedestrians of all abilities. An ADA-compliant crosswalk and curb cut are being installed at the corner of Revere St. and Roosevelt St. near the Paul Revere School.
- Additionally, a state-funded project will be taking place to upgrade infrastructure near the Garfield School, pending final approval by the City Council. The project includes the reconstruction of the concrete sidewalk with vertical granite curb along the west side of Waverly Avenue from Centennial Avenue to the intersection of North Shore Road and Dana Street, reconstruction of concrete sidewalk with vertical granite curb along the south side of Dix Street and the reconstruction of concrete sidewalk with vertical granite curb along the east side of Garfield Avenue from Dix Street to the school driveway. High-visibility crosswalks will be constructed and existing signage will be upgraded where applicable. New crosswalk and stop line pavement markings will be applied where faded.

• ADA-compliant accessible ramps will be constructed for all perpendicular pedestrian crossings and a traffic signal with countdown pedestrian indicators will be installed at the intersection of Waverly Avenue, North Shore Road, and Dana Street.

Item #4: Revere Special Olympics is excited to announce that in addition to bringing back the Young Athletes program for fall of 2017, they will also be offering a fall soccer program for kids 15 and under. Item #5: Monthly Updates-

- The Revere Public Schools, Revere Recreation, and Sepac collaborated this summer to give children with special needs in the extended school year program fun and enriching summer activities. Events included outdoor games, a science show, and a dance party with a DJ. The Commission extends its thanks to Dr. Vadala of the Revere Public Schools for spearheading these efforts.
