Item #1 Presentation by Jay Mazzola from Metro North Regional Emergency Communications Center Will Discuss the 9-1-1 Disability Indicator Forms for Revere Residents: Mr. Mazzola shared the Disability Indicator Form and explained that residents who have a landline should fill out a form. Item #2 Presentation from Lisa Connor and Alan White from TILL: Ms. Connor and Mr. White presented information from TILL (Toward Independent Living and Learning) which is a non-profit human services based in Dedham who provide spectrum services for ages 3 and up. TILL is one of seven support centers in Massachusetts and they are the provider for Revere. Information about TILL can be found on the disabilities website.

Item #3 Update Regarding Commission on Disability State ADA Planning Grant Application: Mr. DeCicco and Mrs. DeMauro. The Revere Commission on Disabilities is seeking a planning grant in the amount of \$125,000.00. If awarded this grant the RCoD will use the funds to meet the Self Awareness & Transition Plan criteria of Title II of the ADA. The funds will also be used to support our 7 person committee in seeking professional development to strengthen the board's knowledge & effectiveness In order to meet the need of our residents. Our commission has been idle for many years. In 2017, the commission was re-established. The commission has been actively responding to the needs of residents with disabilities and meeting monthly to address issues of accessibility and compliance.
