Item #1: Motion to Approve the Meeting Minutes from September 8, 2020 Approved by Enza Goodwin and Second by Pauline Perno

## Item #2: Updates/Next Steps from October Meeting

- Ralph DeCicco announced to the Commission members that Vice Chair Rick Freni was stepping down and read a letter he submitted. This is a tremendous loss for our Commission, and we wish him well.
- Ralph DeCicco also spoke regarding an update from the September meeting regarding Commission member Albert Sheridan and former Vice Chair Rick Freni progress on creating a list of address that presently have a HP sign installed. Since Albert was absent from this meeting it was tabled until next month's meeting.

Item #3: CODA (Commissions on Disabilities Alliance) – Monthly Conference call on October 7, 2020

- Ralph DeCicco mentioned that the Octobers call discussed various city and towns Disability Commissions questioning the necessity/legality/importance of recording COD meetings. During that call he mentioned that Revere had been televising our meetings live along with streaming them on the local cable's YouTube. Channel. He also mentioned that our meetings are rebroadcasted on the local community TV channel for residents to watch anytime. This is so that we have full transparency. If a

resident has a concern or issue of a sensitive manner we could go into Executive session. Since Covid we are also following these procedures. (All Revere Commission members present wayed in on this and fully agreed on our procedures during 10/13 meeting.)

- On the call it was also mentioned that the Disability Summit was discussed on this call and would be taking place virtually on-line this year. The date would be October 29<sup>th</sup> from 9AM 1PM
- There was also a discussion regarding developments asking for parking variances to lower the ratio which also lowers the amount of HP parking spots. Some cities and towns wanted to know what could be done to not allow this to happen. Chair DeCicco mentioned that on the call he explained the problem is the MAAB does not have an amount of parking spaces, it is a ratio formula. The issue is that the ratio is a percentage, not an amount of spaces. It is not an instituted amount of spaces. If the ratio is met, they are meeting the requirements. The AAB would have to change it to have a minimum amount of spaces as opposed to the ratio. Under the present rules cities and towns are following the guidelines. If they are eliminating disabled parking spots for other reasons than there is an issue. The members on the call did not come to any formal decision and agreed that this is an important conversation that they will likely be continuing in the future.
- On the call it was also mentioned that the Disability Summit was discussed on this call and would be taking place virtually on-line this year. The date would be October  $29^{th}$  from 9AM-1PM
