• Discussions and questions regarding if there is any governance under the ADA Taxicab Companies because of discrimination such as service animals being allowed in vehicles. This would be covered under Title III and is illegal. Also, the town of Fall River mentioned and issue with the Cab Company service in their town being 24/7 but only providing service for people in Wheelchairs until 5 PM. This is discriminator if a cab company has the equipment and manpower to be able to provide this service 24 Hrs also. (Discussed As stated)

- Town of Concord mentioned that they now have two adaptive bikes included in their ride share program. They are three-wheel trikes. (Discussed As stated)
- Discussion regarding how some cities and towns have issues finding anyone to serve on their Commissions or if they do have people there are issues with the City or towns process or lack thereof in confirming people to be added to Disability Commission. (Discussed As stated)
