Thursday August 17	5:00 p.m. Last date and time for filing withdrawals from or objections to nomination. Candidates wanting to withdraw must submit a notarized letter. The letter cannot be notarized by the staff in the Election Department.
Thursday August 17	5:01 p.m. Drawing for the ballot position for the Preliminary Election. Drawing is held in the Election Department.
Saturday September 9	5:00 p.m. Last date and time to register to vote for the Preliminary Election.
Monday September 11	5:00 p.m. Last date and time for candidates on the ballot to file their first Campaign Finance report for 2023. Period covered 1/1/2023 – 9/1/2023. When a preliminary is not held, no report is due.
Tuesday September 12	5:00 p.m. Last date and time to post the warrant for the preliminary.

Tuesday **5:00 p.m.** Last date and time to request an absentee ballot **by mail**.
