MINUTES LICENSE COMMISSION MEETING DECEMBER 16, 2016

A REGULAR MEETING OF THE Revere License Commission was called to order by Chairman Joseph W. Quarantello, Jr. at 3:00 p.m. on December 16, 2016. Commissioner Linda Guinasso, Commissioner John M. LaCroix, Police Lt. Sean Randall, Liaison with the Revere License Commission, and Maggie Haney, Recording Secretary, present.

VOTED ON THE FOLLOWING APPLICATIONS SUBMITTED FOR CONSIDERATION

Rogers Realty of Revere, Inc. d/b/a **Shipwreck Lounge** 55 Revere Beach Boulevard Louis Padova, Manager

<u>Application to Amend Entertainment License:</u> Application of Rogers Realty of Revere, Inc. d/b/a Shipwreck Lounge, Louis Padova, Manager, to amend an entertainment license exercised at 55 Revere Beach Boulevard to include karaoke and dancing by patrons. License presently includes cable TV, radio, and jukebox.

The License Commission determined that consideration of this application would be redundant.

Application to Transfer an All Alcohol Package Store License: Application of Nilhar Enterprises, Inc. d/b/a Woody's Liquors, Mitaben Patel, President, Jaimin Patel, Manager, for transfer of an All Alcohol Package Store license from Enterprise Liquor Store, Inc., said license to be exercised at 266 Broadway, Revere, MA. Hours of operation are Sun 10 a.m. – 11 p.m., Mon – Sat 8 a.m. – 11 p.m.

Attorney Lawrence Simeone represented the applicant. The applicant is purchasing the business of Woody's Liquors, and will lease the building from the current owner of the business. Should the application be successful, the current owner will withdraw his appeal with the ABCC protesting the granting of a license to Mahavir Enterprises, at 270 Broadway. Both package stores will be operated by the same family.

Before reaching any decision, the Commission revisited the question of whether the door between the package store and the pizza store should remain open. The current owner is permitted to keep the door open; however, Commissioner Guinasso wished the matter to be put to a vote.

There were neither opponents nor proponents when called. The Commission considered the application separately from the matter of whether the door would remain open between establishments. Upon a motion duly made by Chairman Quarantello, and seconded by Commissioner LaCroix, it was VOTED to approve the application.

There were neither opponents nor proponents when called regarding the matter of the open door. Upon a motion duly made by Chairman Quarantello, and seconded by Commissioner LaCroix, it was VOTED to allow the doors to remain open, with Commissioner Guinasso voting in opposition.

Application to Increase Number of Cars Allowed Under Class 2 Motor Vehicle Dealer License: Application of Circle Auto Gallery, Inc., Kelly Schmeiske, President and Manager, to increase the number of cars allowed for sale under a Class 2 Motor Vehicle Dealer License exercised at 400 Beach Street, Revere, MA. Present number of cars is 10. Requested number of cars is 18.

Attorney Lawrence Simeone represented the applicant, who was also present. He submitted a new plan drawing indicating his client's wish to ask for 20 cars, rather than 18.

There were neither opponents nor proponents when called. Upon a motion duly made by Commissioner Guinasso, and seconded by Commissioner LaCroix, it was VOTED to approve the application, with the following conditions: 19 cars would be allowed for sale, with one of them stored in the garage and 18 outside, and 3 spaces for customer

parking; lines must be painted on the lot indicating all spaces for cars by spring; and the license holder must prevent customers from parking on the sidewalk, directing them to the customer parking.

<u>Hearing:</u> Hearing into possible license violations stemming from an assault on the premises. – **Continued from November meeting.**

Peter DePesa appeared for the hearing, represented by his attorney, Gerry D'Ambrosio. Lt. Randall first read Capt. Reardon's report into the record. The Commission then heard from Atty. D'Ambrosio, and from Detective Bruker of the Revere Police Department. Because of the seriousness of the assault, a criminal investigation is ongoing. After hearing from all parties, it was agreed, for purposes of this hearing, that the assault had been committed by a bouncer employed by the Squire, and that this bouncer is no longer employed there. After due consideration of the matter, the Commission voted as follows.

There were neither opponents nor proponents when called. Upon a motion duly made by Commissioner LaCroix, and seconded by Chairman Quarantello, it was VOTED to require the license holders to provide the License Commission with recommendations to prevent future such occurrences, said recommendations to be provided within 30 days.

Also, upon a motion duly made by Commissioner Guinasso, and seconded by Commissioner LaCroix, it was VOTED to table the matter for six months, pending further issues.

Kenneth LaFauci appeared for the hearing, accompanied by his attorney, Lawrence Simeone. Atty. Simeone contends that his client is ready to fix all outstanding alarm issues, once his plan is approved by the Fire inspector. He complained of insufficient attention lavished on his client by the Fire inspector and the Licensing office, thereby delaying his client's compliance.

The Commission accepted this information. As an aside, Chairman Quarantello again raised the issue of cars in various states of wreckage being parked outside the establishment and under the billboard during hours when the business is closed. Mr. LaFauci said he was "working on it" and would continue to do so.
