There were neither opponents nor proponents when called. Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the application.

<u>Application for (9) 1-day Malt/Wine Licenses:</u> Application of Boston Street Soccer for nine 1-day licenses for Malt/Wine, said licenses to be exercised at Harry Della Russo Stadium on the following dates and times:

Saturday, April 6, 2024 from 4 p.m. – 10 p.m.; Sunday, April 21,2024 from 4 p.m. – 10 p.m.; Sunday, April 28, 2024 from 6 p.m. – 9 p.m.; Sunday, May 12, 2024 from 4 p.m. – 10 p.m.; Sunday, May 26, 2024 from 4 p.m. – 10 p.m.; Sunday, June 9, 2024 from 4 p.m. – 10 p.m.; Sunday, June 23, 2024 from 6 p.m. – 9 p.m.; Sunday, June 30, 2024 from 6 p.m. – 9 p.m.; and Sunday, July 7, 2024 from 6 p.m. – 9 p.m. Events are Semi-Professional Soccer Games. Juan Cardenas appeared for the application. He described the alcohol control measures that are planned during the games. Commissioner Occena expressed concerns about prior issues with trash left behind after the soccer games last year, including beer cans. Mr. Cardena countered that he had experienced trash that was left at the stadium when his teams arrived last year, and said that he has raised this issue with the city's Parks & Recreation department. Commissioner Monroy asked how they handled the issue of trash last year, and was told that they asked people to clean up after themselves. This year, they plan to have volunteers to clean up after the games. Mr. Cardena reiterated his concern about other people's trash, and Chairman Selevitch suggested that Mr. Cardena should take pictures for documentation of any issues to be raised with Parks & Recreation.

There were neither opponents nor proponents when called. Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the application.

Flaming Super Buffet, Inc. d/b/a **Flaming Grill & Buffet** 31F Furlong Drive Ling Chen, Manager

Ling Chen appeared for the application. There will be no changes to the operation of the business other than the ownership. The current owners are selling to family members. Ms. Chen has been managing the business for several years now, with no problems.

Chairman Selevitch raised a concern with **Noah Autobody Repair & Sales, Inc.**, noting that it has no cars for sale and does not appear to have ever opened. Upon a motion duly made by Chairman Selevitch, and seconded by Commissioner Occena, it was VOTED to summon the license holder for a hearing to determine their intentions regarding the use of their Class 2 Motor Vehicle Dealer license.

The Revere Fire Department has reported issues involving the park & fly operations at Emerald Business Enterprises, Inc. d/b/a Rodeway Inn. The licensed business is overflowing the allowed area of operations, exceeding their allowed number of cars, and blocking fire lanes and sidewalks, posing a safety hazard, and blocking emergency services from any access to the building. Upon a motion duly made by Chairman Selevitch, and seconded by Commissioner Monroy, it was VOTED to summon the license holder in for a hearing on these violations.
