## **Meeting Minutes**

May 25, 2022 – 9:00 a.m.

At a meeting of the Revere Retirement System (RRS), held on Wednesday, May 25, 2022, at 9:00 a.m. at 14 Yeamans St., Suite C2, Revere, the following Revere Retirement Board (RRB), members participated: Mr. Viscay, Mr. Cataldo and Mr. Cullen.
