The following must be provided to the Parking Director each year for review and approval:

- A. A letter on business letter head requesting such special consideration;
- B. A list of employees requiring the placards;
- C. A copy of each employee's valid motor vehicle registration;
- D. A point of contact and phone numbers for each Senior Living Facility Administration
- E. Employees may be added to the list throughout the year by providing the required information;
