The City of Revere is soliciting sealed bids for the replacement of emergency generators at the Beachmont School, Lincoln School and Revere High School. The bids will be received at the Office of the Purchasing Agent, City Hall, Revere, Massachusetts until 10:00 AM on Thursday, July 16, 2020 immediately after which the bids will be opened and read publicly.

Specifications may be obtained beginning Thursday, July 2, 2020, at the Office of the Purchasing Agent, Revere City Hall, Revere, Massachusetts or electronically by e-mailing: mpiccardi@revere.org. Mailing of specifications requires advance payment in the form of a bank check or money order, in the amount of \$10.00. Revere City Hall office hours are Monday thru Thursday, 8:15 AM to 5:00 PM and Fridays 8:15 AM to 12:15 PM.

Bids must be sealed and clearly marked "**REPLACEMENT OF EMERGENCY GENERATORS AT BEACHMONT SCHOOL, LINCOLN SCHOOL AND REVERE HIGH SCHOOL**" and be submitted to the Office of the Purchasing Agent prior to 10:00 A.M. on July 16, 2020.

Each general bidder must be certified by DCAMM for the category of work of Mechanical Systems and dollar amount of this Project. Each general bidder must also submit a copy of the Certificate of Eligibility from DCAMM showing that it is eligible to bid on the project, as well as an Update Statement with its bid.

Each bid must be accompanied by a bid deposit in the form of a bid bond, money order, cashier's check, certified check, or a treasurer's check, issued by a responsible bank or trust company, in the amount of five (5) percent of the proposed bid. Checks must be made payable to the City of Revere.

The City of Revere as the awarding authority, may accept any bid or a portion of a bid, waive any irregularities and/or formalities, investigate the ability of the vendors to honor a bid, select a vendor who does not submit the lowest bid and award all contracts as shall be considered in the best interest of the City of Revere.

It is the policy of the City of Revere to take positive steps to maximize the utilization of minority business enterprises in all activities administered by this agency.

No bidder may withdraw his/her bid within thirty (30) business days after the actual date of the opening thereof.

This invitation for bid is in accordance with M.G.L. Chapter 149.
