




MAINE STATUTORY QUIT CLAIM DEED

With Covenant

I, THOMAS L. DICKSON, Jr., of Rumford, County of OXFORD and State of MAINE, for consideration paid, grant to ROBERT E. RICHARDS, of RR1, Box 851, West Rockport, County of Knox, and State of Maine, with Quit Claim Covenants, the land in Weld, Franklin County, Maine, and situated in the northeast corner of Lot Sixteen (16) Range One (1), bounded and described as follows:


Being a portion of the so-called I. T. Hutchinson farm, commencing at a corner where the so-called Frank Barrett farm intersects with the I. T. Hutchinson farm located on the southerly side of an old road leading to the so-called I. White Farm; thence westerly following an old stone wall along the bounds of said road a distance of approximately twenty-one (21) rods and twenty-two (22) feet; thence southerly along the bounds of an old stone wall approximately twenty-one (21) rods and twenty-nine (29) feet; thence easterly along the bounds of an old stone wall a distance of approximately eighteen (18) rods and thirty-one (31) feet; thence northerly a distance of approximately twenty-one (21) rods and forty-two (42) feet to the point of beginning.

The land herein conveyed being bounded on the east and south by the former Frank Barrett farm, and on the west by land formerly of Pearl H. Abbott. Together with a right of way to cross land of the within Grantor using an existing unimproved road from the main road to the premises herein conveyed and described above.
