### **Community Team Allocates LEAP Explosion Funds**

On September 16, 2019 the LEAP building tragically exploded in Farmington killing one firefighter, severely injuring other firefighters and LEAP's maintenance person, displacing 33 people and significantly affecting 14 LEAP employees and two adjacent businesses. United Way of the Tri-Valley Area established the LEAP Explosion Fund immediately after the explosion to help those affected – firefighters, those displaced behind and adjacent to the building and LEAP employees. In all, United Way is approaching \$180,000 in generous gifts from 550 donors. (We recognize generous leadership donors who gave \$350 or more below. Thank you to all.)

The community also generously donated to other funds that were established, including the Go Fund Me page for LEAP employee Larry Lord, the Farmington Firemen's Benevolent Association, and the Farmington Disaster Relief Fund.

United Way has swiftly allocated LEAP Explosion funds to ensure immediate needs were met.

A committee was formed with representatives from the Town of Farmington, the business community, Franklin County Emergency Management, Farmington Police, social service agencies, the mental health field, LEAP and United Way. It has met three times and allocated \$132,985 in immediate funding to help with a variety of needs, including first and last month's rent and security deposits; replacement of household items; transportation costs and infrastructure repair.

The committee is now meeting monthly to steward the remaining dollars so that yet-to-be determined needs can be addressed, such as mental health services and medical needs. The committee is also reviewing ways to potentially provide a community contribution to an affordable housing project grant to leverage additional dollars to provide low-cost housing – which is so hard to find in the region. (This

was demonstrated loud and clear in the weeks following the explosion as United Way, Emergency Management, the Town of Farmington and others were trying to secure housing for those who had been displaced.)

As winter sets in and time passes, the trauma of September 16<sup>th</sup> may be hard to handle alone. Please do not hesitate to reach out for help by calling 211 (24 hours a day), seven days a week for a list of mental health services in the region.
