## Health Notice #66

December 28, 2021

Mt. Blue Regional School District was notified that **11 (eleven)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **29 (twenty-nine)** close contacts were identified and have been notified. Of these close contacts, **20 (twenty)** are required to quarantine and **9 (nine)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
