Health Notice #43

November 18, 2021

Mt. Blue Regional School District was notified that **8 (eight)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **111 (one hundred and eleven)** close contacts were identified and have been notified. Of these close contacts, **61 (sixty-one)** are required to quarantine and **50 (fifty)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
