Health Notice #31

November 2, 2021

Mt. Blue Regional School District was notified that **7 (seven)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **56 (fifty-six)** close contacts were identified and have been notified. Of these close contacts, **35 (thirty-five)** are required to quarantine, and **21 (twenty-one)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
