## Health Notice #35

November 8, 2021

Mt. Blue Regional School District was notified that **4 (four)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **30 (thirty)** close contacts were identified and have been notified. Of these close contacts, **6 (six)** are required to quarantine and **24 (twenty-four)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
