Health Notice #21

October 14, 2021

Mt. Blue Regional School District was notified that **6 (six)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **32 (thirty-two)** close contacts were identified and have been notified. Of these close contacts, **17 (seventeen)** are required to quarantine, and **15 (fifteen)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
