Health Notice #4

September 12th, 2021

Mt. Blue Regional School District was notified today that **two (2)** people associated with our district have tested positive for COVID-19. Contact tracing has just been completed this evening and **44 (forty-four)** close contacts were identified and have been contacted.

One of our cases is a probable positive case, which we are waiting on for the final confirmation of the PCR test. If the PCR test is negative, we will contact those families affected, and their students will be released from quarantine.

Please be assured that our efforts to keep our schools safe continue and that our buildings are cleaned in accordance with all Maine CDC guidelines. *If you have any questions and would like an RSU 9 staff member to reach out to you, please complete this [form](#).* The number of cases and the impacted schools/locations are included below.
