Mt. Blue Regional School District was notified today that **1 (one)** person associated with our district has tested positive for COVID-19. Contact tracing has just been completed and **42 (forty-two)** close contacts were identified and have been contacted.

This case is a probable positive case. If we receive updated information, we will immediately contact those families affected, and their students will be released from quarantine.
