Mt. Blue Regional School District was notified today that **2 (two)** people associated with our district have tested positive for COVID-19. Contact tracing has just been completed and **81 (eighty-one)** close contacts were identified and have been contacted.

One of the cases is a probable positive case. If we receive updated information, we will immediately contact those families affected, and their students will be released from quarantine.
