Mt. Blue Regional School District was notified today that <u>2 (two)</u> people associated with our district have tested positive for COVID-19. Contact tracing has just been completed and <u>81</u> (<u>eighty-one</u>) close contacts were identified and have been contacted.

One of the cases is a probable positive case. If we receive updated information, we will immediately contact those families affected, and their students will be released from quarantine.
