September 15, 2021

Mt. Blue Regional School District was notified today that **7 (seven)** people associated with our district have tested positive for COVID-19. Contact tracing has just been completed and **39 (thirty-nine)** close contacts were identified and have been contacted.

One of the cases is a probable positive case. If we receive updated information, we will immediately contact those families affected, and their students will be released from quarantine.
