September 29, 2021

Mt. Blue Regional School District was notified that **3 (three)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **5 (five)** close contacts were identified and have been notified. Of these close contacts, **1 (one)** is required to quarantine, and **4 (four)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, are fully vaccinated, or were COVID-19 positive in the past 90 days.
